SENATE JOINT RESOLUTION 12-026

101 CONCERNING RECOGNITION OF OCTOBER AS "CONFLICT RESOLUTION
102 MONTH" IN COLORADO.

1 WHEREAS, Conflict resolution encompasses many forms of
2 mediation, arbitration, facilitation, collaborative decision-making,
3 ombuds activities, restorative justice, and other responses to differences;
4 and

5 WHEREAS, These conflict resolution processes empower
6 individuals, families, communities, organizations, and businesses to foster
7 communication and devise solutions that are acceptable and responsive
8 to the needs and interests of all parties involved; and

9 WHEREAS, Conflict resolution is taught and practiced by citizens
10 in many school systems, universities, and graduate programs throughout

1 Colorado and the world as a way of solving disputes; and

2 WHEREAS, Community-based programs work to strengthen local
3 relationships by fairly and equitably resolving neighborhood and
4 community conflicts and opening community dialogues based in reason
5 and mutual respect; and

6 WHEREAS, Professional associations of conflict mediators
7 promote peaceful and creative resolutions to disputes; and

8 WHEREAS, The General Assembly, in passing House Joint
9 Resolution 97-1020, demonstrated its support of Alternative Dispute
10 Resolution (ADR) because of the cost- and time-savings that ADR brings
11 to the handling of disputes by the state court system; and

12 WHEREAS, Additional benefits produced in appropriate cases
13 through facilitative, party-centered mediation include more creative and
14 more durable interest-based resolution; increased satisfaction for the
15 parties who are active participants and ultimate decision-makers in the
16 negotiation; and the preservation of personal relationships, thereby
17 decreasing the likelihood of strained relations among the parties and
18 further disputes; and

19 WHEREAS, Colorado's reputation for working across party lines
20 to enact sound policy has had a very real impact on economic progress
21 and job creation throughout the state; and

22 WHEREAS, Governor John Hickenlooper has proclaimed the
23 month of October to be Conflict Resolution Month in the state of
24 Colorado; now, therefore,

25 *Be It Resolved by the Senate of the Sixty-eighth General Assembly*
26 *of the State of Colorado, the House of Representatives concurring herein:*

27 (1) That we, the members of the Colorado General Assembly, join
28 the Governor in recognizing October 2012 as Conflict Resolution Month
29 in the state;

30 (2) That we invite Coloradans to create events that celebrate and
31 promote the use of productive conflict resolution in their communities;

32 (3) That we call upon leaders across the state to use this month as

1 an occasion to discuss the principles and use the practices of conflict
2 resolution in their homes, schools, neighborhoods, congregations, and
3 workplaces; and

4 (4) That we encourage every citizen of the state to reflect upon the
5 conflicts present in his or her own life and to work responsibly to
6 peacefully resolve those conflicts.

7 *Be It Further Resolved*, That, in conjunction with Conflict
8 Resolution Month in Colorado, October 2012, the General Assembly
9 encourages development of educational and training programs that
10 emphasize the special benefits of facilitative, interest-based,
11 party-centered, and restorative mediation and that bring these special
12 benefits to the attention of judges and other officials and staff in the state
13 court system, state executive branch, and local governments throughout
14 the state.

15 *Be It Further Resolved*, That the General Assembly encourages the
16 participation of judges, other officials and staff in the state judicial
17 branch, state executive branch, and local governments in projects and
18 programs celebrating and observing Conflict Resolution Month 2012;
19 and, like House Joint Resolution 97-1020, that copies of this Joint
20 Resolution be sent to the Chief Justice of the Colorado Supreme Court,
21 the State Court Administrator, the chief judge of each judicial district in
22 the state, and the court administrator of each judicial district in the state.

23 *Be It Further Resolved*, That copies of this Joint Resolution also
24 be sent to Governor John Hickenlooper; Dace West, Director, Denver
25 Office of Strategic Partnerships; Chuck Turner, Executive Director,
26 Colorado Bar Association; Gregory L. Moore, Editor, The Denver Post;
27 Fonda Hamilton, President of the Mediation Association of Colorado;
28 Holly Panetta, Office of Dispute Resolution in the Colorado Judicial
29 Department; Ariana Harner, President, Board of Directors, The Conflict
30 Center; Jim Laurie, President, Board of Directors, the Interfaith Alliance
31 of Colorado; Mary Zinn, President, Zinn Mediation Associates; Barbara
32 Fields, Executive Director, Association for Global New Thought; each of
33 the following organizations for posting on their web sites: The Colorado
