Description: Meets bi-monthly. At least one member shall be appointed from each congressional district. The Governor is required to include representation by at least one member who is a person with a disability, a family member of a person with a disability, or a member of an advocacy group for persons with disabilities. Not more than four members shall be from any one political party. Members shall not serve more than two consecutive full terms.

The board advises the General Assembly, the Governor, and the division on housing matters; establishes uniform construction and maintenance standards for hotels, motels, and multiple dwellings in those areas of the state where no such standards exist; and for factory-built housing; develops and submits to the General Assembly and units of local government recommendations for uniform housing standards and building codes; conducts examinations and investigations and takes testimony and proof under oath at hearings; through the division of housing, acts as agent for local governmental and private nonprofit entities in connection with federal, state, and local public and private nonprofit housing programs; promulgates rules and regulations establishing income limits for the determination of what constitutes a low- or moderate-income family.

The board serves in an advisory capacity to the state housing finance authority.
