## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.HB13-1038 be amended as follows:

- 1 Amend printed bill, page 2, after line 1 insert:
- 2 "SECTION 1. In Colorado Revised Statutes, 1-1-104, add (19.5)  
3 (d) as follows:
- 4 "1-1-104. Definitions. As used in this code, unless the context  
5 otherwise requires:  
6 (19.5) (d) VERIFICATION THAT A VOTER IS COMMITTED TO A  
7 JUVENILE FACILITY AND IN THE CUSTODY OF THE DIVISION OF YOUTH  
8 CORRECTIONS IN THE DEPARTMENT OF HUMAN SERVICES SHALL BE  
9 CONSIDERED SUFFICIENT IDENTIFICATION OF SUCH VOTER FOR THE  
10 PURPOSES OF SECTION 1-2-210.5."
- 11 Renumber succeeding sections accordingly.
- 12 Page 2, line 6, strike "CONFINED" and substitute "COMMITTED".
- 13 Page 2, line 10, strike "CONFINED" and substitute "COMMITTED".
- 14 Page 3, strike lines 10 through 27 and substitute:
- 15 "(2) THE ADMINISTRATOR AND THE SECRETARY OF STATE SHALL  
16 POST THE TYPE OR KIND OF THE VERIFICATION SATISFYING THE  
17 REQUIREMENTS OF SECTION 1-1-104 (19.5) (d) IN A PROMINENT PLACE ON  
18 THE PUBLIC WEB SITES MAINTAINED BY THE DEPARTMENT OF HUMAN  
19 SERVICES AND THE SECRETARY, RESPECTIVELY. THE SECRETARY SHALL  
20 PROVIDE NOTICE TO THE COUNTY CLERK AND RECORDERS AS WELL AS  
21 OTHER DESIGNATED ELECTION OFFICIALS THROUGHOUT THE STATE THAT  
22 SUCH VERIFICATION CONSTITUTES AN ACCEPTABLE FORM OF  
23 IDENTIFICATION UNDER SECTION 1-1-104 (19.5) PERMITTING THE  
24 INDIVIDUALS POSSESSING SUCH IDENTIFICATION TO REGISTER TO VOTE AND  
25 CAST A BALLOT."
- 26 Page 4, strike lines 1 through 4.
- 27 Page 4, line 15, strike "CONFINED" and substitute "COMMITTED".
- 28 Page 4, strike lines 12 through 15 and substitute "19-2-203 (1), C.R.S., A



1 RESIDENTIAL FACILITY OPERATED BY THE DIVISION OF YOUTH  
2 CORRECTIONS, OR A RESIDENTIAL FACILITY THAT CONTRACTS WITH THE  
3 DIVISION OF YOUTH CORRECTIONS IN WHICH A PERSON COMMITTED TO THE  
4 COLORADO DEPARTMENT OF HUMAN SERVICES IS CONFINED AND ELIGIBLE  
5 TO REGISTER TO VOTE AND CAST A BALLOT."

6 Page 5, line 15, strike "CONFINED" and substitute "COMMITTED".

7 Page 5, line 19, strike "CONFINED" and substitute "COMMITTED".

8 Page 6, strike lines 8 through 27 and substitute:

9           "(c) THE ADMINISTRATOR AND THE SECRETARY OF STATE SHALL  
10 POST THE TYPE OR KIND OF THE VERIFICATION SATISFYING THE  
11 REQUIREMENTS OF SECTION 1-1-104 (19.5) (d), C.R.S., IN A PROMINENT  
12 PLACE ON THE PUBLIC WEB SITES MAINTAINED BY THE DEPARTMENT OF  
13 HUMAN SERVICES AND THE SECRETARY, RESPECTIVELY. THE SECRETARY  
14 SHALL PROVIDE NOTICE TO THE COUNTY CLERK AND RECORDERS AS WELL  
15 AS OTHER DESIGNATED ELECTION OFFICIALS THROUGHOUT THE STATE  
16 THAT SUCH VERIFICATION CONSTITUTES AN ACCEPTABLE FORM OF  
17 IDENTIFICATION UNDER SECTION 1-1-104 (19.5), C.R.S., PERMITTING THE  
18 INDIVIDUALS POSSESSING SUCH IDENTIFICATION TO REGISTER TO VOTE AND  
19 CAST A BALLOT."

20 Page 7, strike lines 1 and 2.
