## HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.HB13-1049 be amended as follows:

1 Amend printed bill, page 2, line 4, strike "The" and substitute "EXCEPT AS  
2 OTHERWISE PROVIDED IN PARAGRAPH (b) OF THIS SUBSECTION (1), the".

3 Page 2, strike line 9 and substitute "~~February 1, 1991~~".

4 Page 2, line 10, strike "THIS SUBSECTION (1), all" and substitute "All".

5 Page 3, strike lines 7 through 27 and substitute:

6 "(b) (I) THE BOARD OF COUNTY COMMISSIONERS OF ANY COUNTY  
7 THAT HAS A PUBLIC TRUSTEE WHO IS APPOINTED BY THE GOVERNOR  
8 PURSUANT TO PARAGRAPH (a) OF THIS SUBSECTION (1) MAY ELECT, ON OR  
9 BEFORE JANUARY 12, 2015, TO HAVE THE COUNTY TREASURER SERVE AS  
10 THE PUBLIC TRUSTEE OF THE COUNTY RATHER THAN AN APPOINTEE OF THE  
11 GOVERNOR. IN CONNECTION WITH SUCH ELECTION, THE BOARD OF COUNTY  
12 COMMISSIONERS SHALL SPECIFY THE DATE ON WHICH THE TERM OF THE  
13 CURRENTLY APPOINTED PUBLIC TRUSTEE EXPIRES, NOTWITHSTANDING THE  
14 TERM SPECIFIED IN PARAGRAPH (a) OF THIS SUBSECTION (1), AND THE DATE  
15 ON WHICH THE COUNTY TREASURER OF THE COUNTY BEGINS HIS OR HER  
16 DUTIES AS THE PUBLIC TRUSTEE.

17 (II) A BOARD OF COUNTY COMMISSIONERS SHALL, IN A TIMELY  
18 MANNER, PROVIDE NOTICE OF AN ELECTION PURSUANT TO SUBPARAGRAPH  
19 (I) OF THIS PARAGRAPH (b) TO THE GOVERNOR AND TO THE REVISOR OF  
20 STATUTES AND MAKE INFORMATION ABOUT THE TRANSFER OF DUTIES  
21 CONCERNING THE OFFICE OF THE PUBLIC TRUSTEE AVAILABLE ON THE  
22 COUNTY'S WEB SITE. UPON RECEIPT OF SUCH NOTICE, THE GOVERNOR  
23 SHALL TERMINATE THE APPOINTMENT OF THE PUBLIC TRUSTEE IN THE  
24 APPLICABLE COUNTY AS OF THE DATE SPECIFIED BY THE BOARD OF  
25 COUNTY COMMISSIONERS. THE REVISOR OF STATUTES SHALL KEEP A  
26 RECORD OF THE COUNTIES THAT HAVE MADE AN ELECTION PURSUANT TO  
27 THIS PARAGRAPH (b) IN THE EVENT THAT THE GENERAL ASSEMBLY, ACTING  
28 BY BILL, CHOOSES TO AMEND THE PROVISIONS OF THIS ARTICLE TO  
29 REFLECT WHICH COUNTIES HAVE MADE AN ELECTION PURSUANT TO THIS  
30 PARAGRAPH (b)".

31 Page 4, strike lines 1 though 4 and substitute:

32 "**SECTION 2. Act subject to petition - effective date.** This act  
33 takes".
