HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Judiciary.HB13-1154 be amended as follows:

- 1 Amend printed bill, page 2, line 21, strike "assaults or murders" and
2 substitute "injures".
- 3 Page 3, strike lines 22 and 23.
- 4 Renumber succeeding subsections accordingly.
- 5 Page 4, line 27, strike "AFTER".
- 6 Page 5, line 1, strike "DELIBERATION AND".
- 7 Page 5, line 12, strike "IF, WITH INTENT TO".
- 8 Page 5, strike lines 13 and 14 and substitute "IF THE PERSON KNOWINGLY
9 CAUSES THE UNLAWFUL TERMINATION OF THE PREGNANCY OF A WOMAN."
- 10 Page 5, line 27, strike "6" and substitute "5".
- 11 Page 6, line 6, strike "IF THE PERSON".
- 12 Page 6, strike lines 7 through 9 and substitute "IF, UNDER CIRCUMSTANCES
13 MANIFESTING EXTREME INDIFFERENCE TO THE VALUE OF HUMAN LIFE, THE
14 PERSON KNOWINGLY ENGAGES IN CONDUCT THAT CREATES A GRAVE RISK
15 OF DEATH TO ANOTHER PERSON, AND THEREBY CAUSES THE UNLAWFUL
16 TERMINATION OF THE PREGNANCY OF A WOMAN."
- 17 Page 6, line 16, strike "WOMAN." and substitute "WOMAN AT SUCH TIME
18 AS THE PERSON KNEW OR REASONABLY SHOULD HAVE KNOWN THAT THE
19 WOMAN WAS PREGNANT."
- 20 Page 6, line 18, strike "1 MISDEMEANOR." and substitute "6 FELONY."
- 21 Page 6, line 20, strike "6" and substitute "5".
- 22 Page 6, line 27, strike "CHILD." and substitute "CHILD, BUT ONLY TO THE
23 EXTENT THAT THE PERSON IS A PRINCIPAL IN THE CRIMINAL ACT OR
24 ATTEMPTED CRIMINAL ACT, AS DESCRIBED IN SECTION 18-1-603, C.R.S."



- 1 Page 14, line 7, after "**driving**" insert "**resulting in**".
- 2 Page 14, line 16, after "BICYCLE" insert "RESULTING IN THE UNLAWFUL
- 3 TERMINATION OF PREGNANCY".
- 4 Page 14, strike lines 20 through 23.
- 5 Renumber succeeding C.R.S. section accordingly.
