HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.SB13-213 be amended as follows:

- 1 Amend reengrossed bill, page 20, line 5, strike "EIGHT" and substitute
- 2 "EIGHT, OR, FOR AN INSTITUTE CHARTER SCHOOL THAT DOES NOT SERVE
- 3 GRADES ONE THROUGH EIGHT, THE NUMBER OF AT-RISK PUPILS ENROLLED
- 4 IN THE INSTITUTE CHARTER SCHOOL,".

- 5 Page 34, line 14, strike "EFFECTIVENESS" and substitute "RETURN ON THE
- 6 INVESTMENT".

- 7 Page 52, line 18, after "TAX" insert "REVENUE".

- 8 Page 53, line 26, after "LEVY" insert "PLUS THE AMOUNT OF SPECIFIC
- 9 OWNERSHIP TAX REVENUE PAID TO THE DISTRICT".

- 12 Page 54, line 22, strike "AND".

- 13 Page 54, strike line 23.

- 15 substitute "MAY".

- 16 Page 54, line 25, strike "AT LEAST ONCE".

- 17 Page 57, line 22, strike "22-54.5-203 (3)(e)," and substitute "22-54.5-203
- 18 (3)(d),".

- 19 Page 62, strike line 22 and substitute "AUTHORIZED".

- 20 Page 69, after line 19 insert:
- 21 "(d) ANY PORTION OF THE SPECIFIC OWNERSHIP TAX PAID TO THE
- 22 DISTRICT DOES NOT APPLY IN CALCULATING THE LIMITATION UNDER THIS
- 23 SUBSECTION (4).".

- 24 Reletter succeeding paragraph accordingly.

6 FOR WHICH THE PER PUPIL AMOUNT FOR THE APPLICABLE BUDGET YEAR IS
7 LESS THAN ONE HUNDRED FIFTY-NINE DOLLARS."

9 ""RECIPIENT" MEANS A DISTRICT, OR AN INSTITUTE CHARTER SCHOOL THAT
10 IS NOT A MULTI-DISTRICT ON-LINE SCHOOL,".

18 FOR EACH DISTRICT AND SUPPLEMENTAL PAYMENT RECIPIENT THAT IS A
19 DISTRICT AND WITH THE FUNDING FOR EACH ELIGIBLE INSTITUTE CHARTER
20 SCHOOL AND SUPPLEMENTAL PAYMENT RECIPIENT THAT IS AN INSTITUTE
21 CHARTER SCHOOL AS PROVIDED IN SECTION".

- 23 Page 79, line 8, after "PAYMENT" insert "RECIPIENT THAT IS A".
