Committee on Health & Human Services.HB13-1171 be amended as follows:

1 Amend reengrossed bill, page 3, strike line 18 and substitute:
2 "12-38-111.6, C.R.S."

3 Page 7, after line 7, insert:

4 "SECTION 2. In Colorado Revised Statutes, 12-36-117, add
5 (1.7) as follows:

6 **12-36-117. Unprofessional conduct.** (1.7) A LICENSEE SHALL
7 NOT BE SUBJECT TO DISCIPLINARY ACTION BY THE BOARD FOR ISSUING
8 STANDING ORDERS AND PROTOCOLS REGARDING THE USE OF EPINEPHRINE
9 AUTO-INJECTORS IN A PUBLIC OR NONPUBLIC SCHOOL IN ACCORDANCE
10 WITH THE REQUIREMENTS OF SECTION 22-1-119.5, C.R.S., OR FOR THE
11 ACTIONS TAKEN BY ANY DESIGNATED SCHOOL PERSONNEL WHO
12 ADMINISTER EPINEPHRINE AUTO-INJECTORS IN ACCORDANCE WITH THE
13 REQUIREMENTS OF SECTION 22-1-119.5, C.R.S.

14 **SECTION 3.** In Colorado Revised Statutes, 12-38-125, add (1)
15 (n) as follows:

16 **12-38-125. Exclusions.** (1) No provision of this article shall be
17 construed to prohibit:

18 (n) (I) THE ADMINISTRATION OF EPINEPHRINE AUTO-INJECTORS BY
19 A LICENSEE IN A PUBLIC SCHOOL OR NONPUBLIC SCHOOL PURSUANT TO A
20 POLICY ADOPTED IN ACCORDANCE WITH SECTION 22-1-119.5, C.R.S.;

21 (II) THE ISSUANCE BY AN ADVANCED PRACTICE NURSE WITH
22 PRESCRIPTIVE AUTHORITY OF STANDING ORDERS AND PROTOCOLS FOR THE
23 USE OF EPINEPHRINE AUTO-INJECTORS FOR EMERGENCY USE IN A PUBLIC
24 SCHOOL OR NONPUBLIC SCHOOL PURSUANT TO A POLICY ADOPTED IN
25 ACCORDANCE WITH SECTION 22-1-119.5, C.R.S.; OR

26 (III) THE TRAINING BY A LICENSEE OF DESIGNATED SCHOOL
27 PERSONNEL ON THE RECOGNITION OF THE SYMPTOMS OF ANAPHYLACTIC
28 SHOCK AND ON THE ADMINISTRATION OF EPINEPHRINE AUTO-INJECTORS IN
29 A PUBLIC SCHOOL OR NONPUBLIC SCHOOL PURSUANT TO A POLICY
30 ADOPTED IN ACCORDANCE WITH SECTION 22-1-119.5, C.R.S.

31 **SECTION 4.** In Colorado Revised Statutes, 12-42.5-102, add
32 (42) (b) (XIV) as follows:

33 **12-42.5-102. Definitions.** As used in this article, unless the
34 context otherwise requires or the term is otherwise defined in another part
35 of this article:

36 (42) (b) "Wholesale distribution" does not include:

37 (XIV) THE DISTRIBUTION, DONATION, OR SALE BY A



1 MANUFACTURER OR WHOLESALER OF A STOCK SUPPLY OF EPINEPHRINE
2 AUTO-INJECTORS TO PUBLIC SCHOOLS OR NONPUBLIC SCHOOLS FOR
3 EMERGENCY USE BY DESIGNATED SCHOOL PERSONNEL IN ACCORDANCE
4 WITH THE REQUIREMENTS OF SECTION 22-1-119.5, C.R.S."
