SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.SB13-213 be amended as follows:

- 1 Amend printed bill, page 43, strike lines 9 through 14 and substitute:
2 "(b) **Mill levy equalization factor.** THE DEPARTMENT SHALL
3 ANNUALLY CALCULATE THE MILL LEVY EQUALIZATION FACTOR FOR EACH
4 INSTITUTE CHARTER SCHOOL AS FOLLOWS:
5 (I) IF THE INSTITUTE CHARTER SCHOOL IS A QUALIFIED CHARTER
6 SCHOOL, AS DEFINED IN SECTION 22-54.5-308 (1) (d), AND IS NOT A
7 MULTI-DISTRICT ON-LINE SCHOOL, THE DEPARTMENT SHALL CALCULATE
8 THE MILL LEVY EQUALIZATION FACTOR AS FOLLOWS:
9 (A) THE LESSER OF THE PER PUPIL MILL LEVY EQUALIZATION PLUS
10 FOUR HUNDRED DOLLARS, OR TWENTY-FIVE PERCENT OF THE STATEWIDE
11 BASE PER PUPIL FUNDING FOR THE APPLICABLE BUDGET YEAR; DIVIDED BY
12 (B) THE ACCOUNTING DISTRICT'S PER PUPIL FUNDING.
13 (II) IF THE INSTITUTE CHARTER SCHOOL IS NOT A QUALIFIED
14 CHARTER SCHOOL AS DEFINED IN SECTION 22-54.5-308 (1) (d), THE
15 DEPARTMENT SHALL CALCULATE THE MILL LEVY EQUALIZATION FACTOR
16 AS FOLLOWS:
17 (A) THE LESSER OF THE PER PUPIL MILL LEVY EQUALIZATION OR
18 TWENTY-FIVE PERCENT OF THE STATEWIDE BASE PER PUPIL FUNDING FOR
19 THE APPLICABLE BUDGET YEAR; DIVIDED BY
20 (B) THE ACCOUNTING DISTRICT'S PER PUPIL FUNDING.
21 (c) **Mill levy equalization.** THE DEPARTMENT SHALL ANNUALLY
22 CALCULATE THE PER".

- 24 Reletter succeeding paragraph accordingly.
- 25 Page 90, line 21, strike "(a)".
- 26 Page 90, strike line 27.
- 27 Page 91, strike lines 1 through 5.
- 28 Page 91, line 9, strike "AND FOR ALL".
- 29 Page 91, line 10, strike "ELIGIBLE INSTITUTE CHARTER SCHOOLS".
- 30 Page 91, line 14, strike "AND EACH ELIGIBLE INSTITUTE".



1 Page 91, strike lines 15 through 20 and substitute "AN AMOUNT EQUAL TO
2 THE PERCENTAGE OF THE SUM OF THE DISTRICT'S CERTIFIED CHARTER
3 SCHOOL AVERAGE DAILY MEMBERSHIP FOR ALL ELIGIBLE DISTRICTS IN THE
4 STATE THAT IS ATTRIBUTABLE TO THE ELIGIBLE DISTRICT, MULTIPLIED BY
5 THE".

6 Page 92, strike line 5.

7 Page 92, line 6, strike "SECTION 22-30.5-513.5 (2)." and substitute
8 "22-30.5-111.5 (2)".

9 Page 92, line 13, strike "AND ELIGIBLE INSTITUTE CHARTER SCHOOL".

10 Page 92, line 25, strike "OR ELIGIBLE INSTITUTE CHARTER SCHOOL".

11 Page 158, strike lines 10 through 27.

12 Reletter succeeding paragraphs accordingly.
