Committee on Finance.

HB13-1272 be amended as follows:

1 Amend printed bill, page 3, after line 12 insert:

2 "SECTION 3. In Colorado Revised Statutes, add 32-9-119.2 as  
3 follows:

4 **32-9-119.2. Sales and use tax revenue - candy and soft drinks**  
5 **- limit - definitions.** (1) AS USED IN THIS SECTION:

6 (a) "CANDY" HAS THE SAME MEANING AS SET FORTH IN SECTION  
7 39-26-707 (1.5) (b) (I), C.R.S.

8 (b) "SOFT DRINKS" HAS THE SAME MEANING AS SET FORTH IN  
9 SECTION 39-26-707 (1.5) (b) (II), C.R.S.

10 (2) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE TOTAL  
11 SALES AND USE TAX COLLECTED BY THE DISTRICT FOR CANDY AND SOFT  
12 DRINKS IN A FISCAL YEAR SHALL NOT EXCEED THE TOTAL TAX COLLECTED  
13 ON CANDY AND SOFT DRINKS FOR THE FISCAL YEAR 2013-14, ADJUSTED  
14 EACH YEAR THEREAFTER FOR INFLATION. ONCE THE DISTRICT REACHES  
15 THIS LIMIT FOR A FISCAL YEAR, CANDY AND SOFT DRINKS ARE EXEMPT  
16 FROM THIS TAX UNTIL THE END OF THE FISCAL YEAR."

17 Renumber succeeding sections accordingly.

18 Page 4, after line 8 insert:

19 "SECTION 5. In Colorado Revised Statutes, add 32-13-115 as  
20 follows:

21 **32-13-115. Sales and use tax revenue - candy and soft drinks**  
22 **- limit - definitions.** (1) AS USED IN THIS SECTION:

23 (a) "CANDY" HAS THE SAME MEANING AS SET FORTH IN SECTION  
24 39-26-707 (1.5) (b) (I), C.R.S.

25 (b) "SOFT DRINKS" HAS THE SAME MEANING AS SET FORTH IN  
26 SECTION 39-26-707 (1.5) (b) (II), C.R.S.

27 (2) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, THE TOTAL  
28 SALES AND USE TAX COLLECTED BY THE DISTRICT FOR CANDY AND SOFT  
29 DRINKS IN A FISCAL YEAR SHALL NOT EXCEED THE TOTAL TAX COLLECTED  
30 ON CANDY AND SOFT DRINKS FOR THE FISCAL YEAR 2013-14, ADJUSTED  
31 EACH YEAR THEREAFTER FOR INFLATION. ONCE THE DISTRICT REACHES  
32 THIS LIMIT FOR A FISCAL YEAR, CANDY AND SOFT DRINKS ARE EXEMPT  
33 FROM THIS TAX UNTIL THE END OF THE FISCAL YEAR."
