HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on Local Government.

HB13-1118 be amended as follows:

1 Amend printed bill, page 3, strike lines 25 through 27 and substitute:

2 "(4) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
3 CONTRARY, A LAW ENFORCEMENT AGENCY OF THE STATE SHALL NOT BE
4 REQUIRED TO ISSUE A PHOTOGRAPHIC IDENTIFICATION TO A PARTICULAR
5 PEACE OFFICER IF THE CHIEF ADMINISTRATIVE OFFICER OF THE AGENCY
6 ELECTS NOT TO DO SO."

7 Page 4, strike line 1.

8 Page 5, strike lines 3 through 6 and substitute:

9 "(4) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
10 CONTRARY, THE DEPARTMENT OF LAW SHALL NOT BE REQUIRED TO ISSUE
11 A PHOTOGRAPHIC IDENTIFICATION TO A PARTICULAR PEACE OFFICER IF THE
12 ATTORNEY GENERAL ELECTS NOT TO DO SO."

13 Page 6, strike lines 9 through 11 and substitute:

14 "(4) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
15 CONTRARY, A SHERIFF'S OFFICE SHALL NOT BE REQUIRED TO ISSUE A
16 PHOTOGRAPHIC IDENTIFICATION TO A PARTICULAR PEACE OFFICER IF THE
17 SHERIFF ELECTS NOT TO DO SO."

18 Page 7, strike lines 14 through 17 and substitute:

19 "(4) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
20 CONTRARY, A POLICE DEPARTMENT SHALL NOT BE REQUIRED TO ISSUE A
21 PHOTOGRAPHIC IDENTIFICATION TO A PARTICULAR PEACE OFFICER IF THE
22 CHIEF ADMINISTRATIVE OFFICER OF THE POLICE DEPARTMENT ELECTS NOT
23 TO DO SO."

24 Page 8, strike lines 26 and 27 and substitute:

25 "(4) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
26 CONTRARY, A LAW ENFORCEMENT AGENCY OF AN INSTITUTION OF HIGHER
27 EDUCATION SHALL NOT BE REQUIRED TO ISSUE A PHOTOGRAPHIC
28 IDENTIFICATION TO A PARTICULAR PEACE OFFICER IF THE CHIEF

1 ADMINISTRATIVE OFFICER OF THE AGENCY ELECTS NOT TO DO SO."

2 Page 9, strike lines 1 through 3.

3 Page 10, strike lines 10 through 13 and substitute:

4 "(4) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
5 CONTRARY, A LAW ENFORCEMENT AGENCY OF THE DEPARTMENT SHALL
6 NOT BE REQUIRED TO ISSUE A PHOTOGRAPHIC IDENTIFICATION TO A
7 PARTICULAR PEACE OFFICER IF THE CHIEF ADMINISTRATIVE OFFICER OF
8 THE AGENCY ELECTS NOT TO DO SO."

9 Page 11, strike lines 20 through 23 and substitute:

10 "(4) NOTWITHSTANDING ANY PROVISION OF THIS SECTION TO THE
11 CONTRARY, A LAW ENFORCEMENT AGENCY OF THE DEPARTMENT SHALL
12 NOT BE REQUIRED TO ISSUE A PHOTOGRAPHIC IDENTIFICATION TO A
13 PARTICULAR PEACE OFFICER IF THE CHIEF ADMINISTRATIVE OFFICER OF
14 THE AGENCY ELECTS NOT TO DO SO."
