HOUSE COMMITTEE OF REFERENCE AMENDMENT

Committee on State, Veterans, & Military Affairs.HB13-1147 be amended as follows:

1 Amend printed bill, strike everything below the enacting clause and
2 substitute:

3 "SECTION 1. In Colorado Revised Statutes, add 1-2-213.5 as
4 follows:

5 **1-2-213.5. State institutions of higher education - electronic**
6 **voter registration option - information to students.** (1) (a) ANY STATE
7 INSTITUTION OF HIGHER EDUCATION, AS DEFINED IN SECTION 23-1-108 (7)
8 (g) (II), C.R.S., THAT UTILIZES AN ELECTRONIC COURSE REGISTRATION
9 PROCESS SHALL PROVIDE TO EACH STUDENT REGISTERING
10 ELECTRONICALLY FOR COURSES AT THE INSTITUTION THE OPPORTUNITY TO
11 REGISTER TO VOTE BY GIVING EACH STUDENT THE OPTION TO BE
12 ELECTRONICALLY DIRECTED TO THE OFFICIAL WEB SITE OF THE SECRETARY
13 OF STATE SO THAT HE OR SHE MAY REGISTER IN ACCORDANCE WITH
14 SECTION 1-2-202.5. THE OPTION SHALL BE PROVIDED TO STUDENTS EITHER
15 DURING OR IMMEDIATELY FOLLOWING THE COMPLETION OF EACH
16 ELECTRONIC COURSE REGISTRATION PROCESS.

17 (b) EACH STATE INSTITUTION OF HIGHER EDUCATION SUBJECT TO
18 PARAGRAPH (a) OF THIS SUBSECTION (1) SHALL IMPLEMENT THE
19 ELECTRONIC VOTER REGISTRATION OPTION AS SOON AS PRACTICABLE, BUT
20 NOT LATER THAN THE NEXT REGULARLY SCHEDULED MAINTENANCE TO ITS
21 ELECTRONIC COURSE REGISTRATION SYSTEM PROCESS.

22 (2) A STATE INSTITUTION OF HIGHER EDUCATION THAT DOES NOT
23 UTILIZE AN ELECTRONIC COURSE REGISTRATION PROCESS SHALL PROVIDE
24 TO STUDENTS INFORMATION REGARDING HOW TO REGISTER TO VOTE,
25 INCLUDING, AT A MINIMUM, PROMINENTLY POSTING SUCH INFORMATION
26 IN A CLEARLY VISIBLE AREA OF THE INSTITUTION'S REGISTRAR'S OFFICE.

27 **SECTION 2. Act subject to petition - effective date.** This act
28 takes effect at 12:01 a.m. on the day following the expiration of the
29 ninety-day period after final adjournment of the general assembly (August
30 7, 2013, if adjournment sine die is on May 8, 2013); except that, if a
31 referendum petition is filed pursuant to section 1 (3) of article V of the
32 state constitution against this act or an item, section, or part of this act
33 within such period, then the act, item, section, or part will not take effect
34 unless approved by the people at the general election to be held in
35 November 2014 and, in such case, will take effect on the date of the
36 official declaration of the vote thereon by the governor."
