SENATE COMMITTEE OF REFERENCE AMENDMENT

Committee on Education.

SB13-213 be amended as follows:

1 Amend printed bill, page 16, line 12, strike "(3)" and substitute "(4)" and
2 strike "(3)" and substitute "(4)".

3 Page 18, after line 18 insert:

4 "(b) NOTWITHSTANDING THE PROVISIONS OF PARAGRAPH (a) OF
5 THIS SUBSECTION (7), FOR AN INSTITUTE CHARTER SCHOOL THAT DOES NOT
6 ENROLL STUDENTS IN GRADES ONE THROUGH EIGHT, "AT-RISK PUPIL
7 PERCENTAGE" MEANS THE NUMBER OF AT-RISK PUPILS ENROLLED IN THE
8 INSTITUTE CHARTER SCHOOL EACH SCHOOL DAY, TOTALED FOR THE
9 AVERAGING PERIOD AND DIVIDED BY THE NUMBER OF SCHOOL DAYS IN THE

11 AVERAGE DAILY MEMBERSHIP FOR THE SAME AVERAGING PERIOD."

16 LANGUAGE LEARNER AVERAGE DAILY MEMBERSHIP OF THE FIRST HALF OF
17 THE THEN-CURRENT SCHOOL YEAR AND ADJUST THE CHARTER SCHOOL'S
18 FUNDING ACCORDINGLY FOR THE REMAINDER OF THE FIRST SCHOOL
19 YEAR.".

32 DISTRICT SHALL RECALCULATE THE CHARTER SCHOOL'S FUNDING USING
33 THE AVERAGE DAILY MEMBERSHIP OR ON-LINE AVERAGE DAILY
34 MEMBERSHIP, WHICHEVER IS APPLICABLE, AND THE AT-RISK PUPIL
35 AVERAGE DAILY MEMBERSHIP AND ENGLISH LANGUAGE LEARNER



1 AVERAGE DAILY MEMBERSHIP OF THE FIRST HALF OF THE THEN-CURRENT
2 SCHOOL YEAR AND ADJUST THE CHARTER SCHOOL'S FUNDING
3 ACCORDINGLY FOR THE REMAINDER OF THE SECOND SCHOOL YEAR."

5 (d) IN THE FIRST AND SECOND YEARS IN WHICH A NEW INSTITUTE
6 CHARTER SCHOOL ENROLLS PUPILS AND IN ANY SCHOOL YEAR IN WHICH AN
7 INSTITUTE CHARTER SCHOOL ADDS GRADE LEVELS, THE INSTITUTE SHALL
8 CALCULATE THE INSTITUTE CHARTER SCHOOL'S MEMBERSHIP AND, IF
9 APPLICABLE, ON-LINE PUPIL ENROLLMENT AND ASCENT PROGRAM
10 ENROLLMENT AS PROVIDED IN SECTION 22-54.5-405 (4) AND (6).".

11 Page 157, strike lines 7 through 11.

12 Page 157, line 12, strike "(B)" and substitute "(II) (A)".

13 Reletter succeeding sub-subparagraphs accordingly.

14 Page 170, after line 18 insert:

15 "(d) THE REQUIREMENTS SPECIFIED IN THIS SUBSECTION (4) TO
16 REPORT INFORMATION AT THE SCHOOL-SITE LEVEL APPLY TO THE 2014-15
17 BUDGET YEAR AND BUDGET YEARS THEREAFTER.".

18 Page 170, line 19, strike "(d)" and substitute "(e)".
