Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

HB13-1110 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend the House Transportation & Energy Committee Report dated
2 February 13, 2013, page 5, after line 11 insert:

3 "Page 15, after line 20 insert:

4 **"SECTION 13. Appropriation.** (1) In addition to any other
5 appropriation, there is hereby appropriated, out of any moneys in the
6 Colorado state titling and registration account in the highway users tax
7 fund created in section 42-1-211 (2), Colorado Revised Statutes, not
8 otherwise appropriated, to the department of revenue, for the fiscal year
9 beginning July 1, 2013, the sum of \$68,212, or so much thereof as may
10 be necessary, to be allocated to the information technology division for
11 the purchase of computer center services for the implementation of this
12 act.

13 (2) In addition to any other appropriation, there is hereby
14 appropriated to the governor - lieutenant governor - state planning and
15 budgeting, for the fiscal year beginning July 1, 2013, the sum of \$68,212,
16 or so much thereof as may be necessary, for allocation to the office of
17 information technology, for the provision of computer center services for
18 the department of revenue related to the implementation of this act. Said
19 sum is from reappropriated funds received from the department of
20 revenue out of the appropriation made in subsection (1) of this section.

21 (3) In addition to any other appropriation, there is hereby
22 appropriated, out of any moneys in the highway users tax fund created in

1 section 43-4-201 (1) (a), Colorado Revised Statutes, and appropriated
2 pursuant to section 43-4-201 (3) (a) (V), Colorado Revised Statutes, not
3 otherwise appropriated, to the department of revenue, for the fiscal year
4 beginning July 1, 2013, the sum of \$110,400, or so much thereof as may
5 be necessary, for allocation to the taxpayer service division for computer
6 programming services related to the implementation of this act.

7 (4) In addition to any other appropriation, there is hereby
8 appropriated, out of any moneys in the license plate cash fund created in
9 section 42-3-301 (1) (b), Colorado Revised Statutes, not otherwise
10 appropriated, to the department of revenue, for the fiscal year beginning
11 July 1, 2013, the sum of \$9,204, or so much thereof as may be necessary,
12 for allocation to division of motor vehicles for the purchase of decals
13 related to the implementation of this act."

14 Renumber succeeding section accordingly."

15 Page 5 of the report, line 12, strike "2 and 11" and substitute "2, 11, and
16 13".

17 Page 5 of the report, after line 13 insert:

18 "Page 1, line 102, strike "STATE." and substitute "STATE, AND, IN
19 CONNECTION THEREWITH, MAKING AN APPROPRIATION."."
