HB13-1081 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

- 8 "(c) DISCUSSIONS AND INFORMATION ON HOW TO RECOGNIZE AND
9 RESPOND SAFELY AND EFFECTIVELY IN SITUATIONS WHERE SEXUAL OR
10 PHYSICAL VIOLENCE MAY BE OCCURRING OR WHERE THERE MAY BE A RISK
11 FOR THESE BEHAVIORS TO OCCUR;"

- 13 Page 13, line 7, strike "(IV)" and substitute "(e)".
- 14 Page 13, line 11, after "STANDARDS," insert "REQUIREMENTS,".
- 15 Page 15, line 24, strike "GUIDELINES" and substitute "REQUIREMENTS FOR
16 COMPREHENSIVE HUMAN SEXUALITY CURRICULUM".
- 17 Page 17, line 2, strike "GRADE." and substitute "GRADE UNLESS THE
18 CONTENT OF THE INSTRUCTION RELATES TO PERSONAL HYGIENE, HEALTHY
19 HABITS, RESPECTING PERSONAL SPACE AND BOUNDARIES, INTERPERSONAL
