Committee on Appropriations.

After consideration on the merits, the Committee recommends the following:

SB13-039 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend reengrossed bill, page 26, after line 4 insert:

2           **"SECTION 6. Appropriation.** (1) In addition to any other  
3 appropriation, there is hereby appropriated, out of any moneys in the  
4 division of professions and occupations cash fund created in section 24-  
5 34-105 (2) (b) (I), Colorado Revised Statutes, not otherwise appropriated,  
6 to the department of regulatory agencies, for the fiscal year beginning  
7 July 1, 2013, the sum of \$58,966 and 0.6 FTE, or so much thereof as may  
8 be necessary, to be allocated for the implementation of this act as follows:  
9           (a) \$33,342 and 0.6 FTE to the division of professions and  
10 occupations for personal services;  
11           (b) \$1,863 to the division of professions and occupations for  
12 operating expenses and capital outlay;  
13           (c) \$1,474 to the division of professions and occupations for  
14 disciplinary actions;  
15           (d) \$11,294 to the executive director's office and administrative  
16 services for the purchase of legal services; and  
17           (e) \$10,993 to the executive director's office and administrative  
18 services for the purchase of computer center services.  
19           (2) In addition to any other appropriation, there is hereby  
20 appropriated to the department of law, for the fiscal year beginning July  
21 1, 2013, the sum of \$11,294, or so much thereof as may be necessary, for  
22 the provision of legal services for the department of regulatory agencies  
23 related to the implementation of this act. Said sum is from reappropriated

1 funds received from the department of regulatory agencies out of the  
2 appropriation made in paragraph (d) of subsection (1) of this section.  
3 (3) In addition to any other appropriation, there is hereby  
4 appropriated to the governor - lieutenant governor - state planning and  
5 budgeting, for the fiscal year beginning July 1, 2013, the sum of \$10,993,  
6 or so much thereof as may be necessary, for allocation to the office of  
7 information technology, for the provision of computer center services for  
8 the department of regulatory agencies related to the implementation of  
9 this act. Said sum is from reappropriated funds received from the  
10 department of regulatory agencies out of the appropriation made in  
11 paragraph (e) of subsection (1) of this section."

12 Renumber succeeding section accordingly.

13 Page 1, line 101, strike "AUDIOLOGISTS." and substitute "AUDIOLOGISTS,  
14 AND, IN CONNECTION THEREWITH, MAKING AN APPROPRIATION."
