- 4 Page 3, line 22, strike "THREE" and substitute "FOUR".
  
- 5 Page 3, line 23, strike "ONE" and substitute "TWO".
  
- 6 Page 3, line 25, strike "THREE" and substitute "FOUR".
  
- 7 Page 3, line 27, strike "ONE" and substitute "TWO".
  
- 8 Page 5, line 2, after the period add "WHILE THE LEGISLATIVE COMMITTEE
- 9 MAY CONSIDER AND TAKE INTO ACCOUNT ISSUES AND INFORMATION
- 10 CONCERNING PRESCHOOL AND EDUCATION IN GRADES KINDERGARTEN
- 11 THROUGH SECOND, THE LEGISLATIVE COMMITTEE'S RECOMMENDATIONS
