After consideration on the merits, the Committee recommends the following:

HB13-1079 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, line 9, after "(2)" insert "(a)".
- 2 Page 3, line 2, strike "(a)" and substitute "(I)".
- 3 Page 3, strike lines 3 through 6.
- 4 Page 3, line 7, strike "TERMINAL EQUIPMENT,".
- 5 Page 3, line 9, strike "(b)" and substitute "(II)".
- 6 Page 3, line 13, strike "(c)" and substitute "(III)".
- 7 Page 3, line 19, strike "AND".
- 8 Page 3, line 20, strike "(d)" and substitute "(IV)".
- 9 Page 3, line 22, strike "PROCESSES." and substitute "PROCESSES; AND".
- 10 Page 3, after line 22 insert:
 - 11 "(b) "INFORMATION TECHNOLOGY" DOES NOT MEAN
 - 12 POST-IMPLEMENTATION SUPPORT, HARDWARE LIFE-CYCLE REPLACEMENT,
 - 13 OR ROUTINE MAINTENANCE."
- 14 Page 3, after line 24 insert:

1 "(4) "OVERSEE" MEANS REVIEWS OF SIGNIFICANT INFORMATION
2 TECHNOLOGY PROJECTS, REVIEWS OF THE OFFICE'S BUDGET REQUESTS FOR
3 INFORMATION TECHNOLOGY PROJECTS, AND ENSURING THAT INFORMATION
4 TECHNOLOGY PROJECTS FOLLOW BEST PRACTICE STANDARDS AS
5 ESTABLISHED BY THE OFFICE OF INFORMATION TECHNOLOGY. "OVERSEE"
6 DOES NOT INCLUDE INTERFERENCE WITH THE OFFICE'S GENERAL
7 RESPONSIBILITIES SET FORTH IN THIS ARTICLE."

8 Renumber succeeding subsection accordingly.

9 Page 4, line 4, strike "EDUCATION." and substitute "EDUCATION,
10 INCLUDING THE AURARIA HIGHER EDUCATION CENTER ESTABLISHED IN
11 ARTICLE 70 OF TITLE 23, C.R.S."

12 Page 4, strike line 15 and substitute "INFORMATION TECHNOLOGY,
13 BUSINESS ANALYSIS, OR BUSINESS PROCESS."

14 Page 5, line 10, after "ONCE" insert "EACH YEAR".

15 Page 5, line 11, strike "BUT MAY" and substitute "AND SHALL".

16 Page 5, strike line 17.

17 Renumber succeeding subparagraphs accordingly.

18 Page 6, strike lines 10 through 12.

19 Renumber succeeding subsections accordingly.

20 Page 7, line 1, strike "(7)" and substitute "(6)".

21 Page 7, line 4, strike "LEGISLATIVE AND".

22 Page 7, strike lines 19 and 20 and substitute:

23 "(9) ON OR BEFORE THE FIRST DAY OF THE REGULAR LEGISLATIVE
24 SESSION COMMENCING ON OR AFTER JANUARY 1, 2014, AND ON THE FIRST
25 DAY OF EACH REGULAR LEGISLATIVE SESSION THEREAFTER, THE JOINT
26 TECHNOLOGY COMMITTEE SHALL".

27 Page 7, line 23, strike "(9)" and substitute "(8)".

1 Page 8, line 4, strike "(9)" and substitute "(8)".

2 Page 8, line 21, strike "LEGISLATIVE AND".

3 Page 8, line 22, strike "DEPARTMENTS," and substitute "DEPARTMENT,".

4 Page 9, strike lines 4 through 8 and substitute:

5 **"2-3-1605. Staff assistance.** THE LEGISLATIVE COUNCIL STAFF
6 AND THE OFFICE OF LEGISLATIVE LEGAL SERVICES SHALL ASSIST THE JOINT
7 TECHNOLOGY COMMITTEE IN CARRYING OUT ITS DUTIES.

8 **2-3-1606. Repeal.** THIS PART 16 IS REPEALED, EFFECTIVE JULY 1,
9 2018."

10 Page 12, line 14, after the period add "If A MEETING IS NECESSARY FOR
11 THE REPORTS REQUIRED IN THIS PARAGRAPH (a), THE MEETING SHALL BE
12 A JOINT MEETING OF THE JOINT TECHNOLOGY COMMITTEE AND THE JOINT
13 BUDGET COMMITTEE."

14 Page 12, strike lines 21 through 27.

15 Strike page 13.

16 Page 14, strike lines 1 through 11.

17 Renumber succeeding sections accordingly.

18 Page 14, line 24, strike "and (6)".

19 Page 15, strike lines 10 through 27.

20 Strike page 16.

21 Renumber succeeding sections accordingly.

22 Page 17, strike lines 17 through 20 and substitute:

23 **"24-37.7-113.5. Annual report.** ON OR BEFORE NOVEMBER 1,
24 2013, AND ON NOVEMBER 1 OF EACH YEAR THEREAFTER, THE AUTHORITY
25 SHALL SUBMIT A REPORT THAT SETS FORTH A COMPLETE AND"
