HB14-1139 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 11, line 27, strike "2015-16" and substitute  
2 "2016-17".
- 3 Page 14, line 23, strike "If" and substitute "FOR THE 2017-18 BUDGET  
4 YEAR AND BUDGET YEARS THEREAFTER, IF".
- 5 Page 17, after line 16 insert:  
6 "(c) THE PROVISIONS OF THIS SUBSECTION (5) APPLY TO THE  
7 2017-18 BUDGET YEAR AND BUDGET YEARS THEREAFTER.".
- 8 Page 18, line 13, after "INCLUDING" insert "FOR THE 2017-18 BUDGET  
9 YEAR, AND BUDGET YEARS THEREAFTER,".
- 10 Page 18, line 16, after "INCLUDING" insert "FOR THE 2017-18 BUDGET  
11 YEAR, AND BUDGET YEARS THEREAFTER,".
- 12 Page 19, line 4, strike the second "THE" and substitute "FOR THE 2017-18  
13 BUDGET YEAR, AND BUDGET YEARS THEREAFTER, THE".
- 14 Page 19, line 13, after "INCLUDING" insert "FOR THE 2017-18 BUDGET  
15 YEAR, AND BUDGET YEARS THEREAFTER,".
- 16 Page 19, line 18, strike "THE" and substitute "FOR THE 2017-18 BUDGET  
17 YEAR, AND BUDGET YEARS THEREAFTER, THE".

- 1 Page 21, line 5, after "ADJUSTED" insert "IN THE 2017-18 BUDGET YEAR  
2 AND IN BUDGET YEARS THEREAFTER,".
- 3 Page 21, line 7, after "ADJUSTED" insert "IN THE 2017-18 BUDGET YEAR  
4 AND IN BUDGET YEARS THEREAFTER,".
- 5 Page 21, line 14, after "WITHHELD," insert "IN THE 2017-18 BUDGET YEAR  
6 AND IN BUDGET YEARS THEREAFTER,".
- 7 Page 21, line 24, strike "2015-16" and substitute "2016-17".
- 8 Page 22, line 18, strike "2015-16" and substitute "2016-17".
- 9 Page 23, line 9, strike "IF" and substitute "FOR THE 2017-18 BUDGET  
10 YEAR, AND BUDGET YEARS THEREAFTER, IF".
- 11 Page 29, line 12, strike "CONTRARY:" and substitute "CONTRARY, FOR THE  
12 2017-18 BUDGET YEAR, AND BUDGET YEARS THEREAFTER:".
- 13 Page 31, line 8, after "(o)," insert "(2.5),".
- 14 Page 33, after line 20 insert:  
15 "(2.5) (a) EACH QUALIFYING SCHOOL DISTRICT SHALL PAY TO EACH  
16 DISTRICT CHARTER SCHOOL THE AMOUNTS THAT ARE DUE TO EACH  
17 DISTRICT CHARTER SCHOOL AS PROVIDED IN THIS SECTION. THE  
18 QUALIFYING SCHOOL DISTRICT SHALL PAY THE AMOUNTS IN TWELVE  
19 MONTHLY INSTALLMENTS AS SOON AS PRACTICABLE AFTER THE  
20 QUALIFYING SCHOOL DISTRICT RECEIVES DISTRIBUTIONS OF MONEYS FROM  
21 THE DEPARTMENT PURSUANT TO SECTION 22-54-115.  
22 (b) FOR THE 2017-18 BUDGET YEAR, AND BUDGET YEARS  
23 THEREAFTER, IF A QUALIFYING SCHOOL DISTRICT'S TOTAL PROGRAM  
24 FUNDING IS ADJUSTED MID-YEAR PURSUANT TO SECTION 22-54-112.5 (4),  
25 THE QUALIFYING SCHOOL DISTRICT SHALL ADJUST THE DISTRIBUTION TO  
26 THE DISTRICT CHARTER SCHOOLS ACCORDINGLY.".
- 27 Page 37, line 12, strike "CONTRARY:" and substitute "CONTRARY, FOR THE  
28 2017-18 BUDGET YEAR, AND BUDGET YEARS THEREAFTER:".
