After consideration on the merits, the Committee recommends the following:

HB14-1100 be amended as follows, and as so amended, be referred to the Committee on Appropriations with favorable recommendation:

- 1 Amend printed bill, page 2, strike line 13.
- 2 Reletter succeeding paragraphs accordingly.
- 3 Page 2, strike line 15.
- 4 Reletter succeeding paragraphs accordingly.
- 5 Page 3, strike line 5 and substitute "SUBMERGED IN WATER TO THE POINT
- 6 THAT RISING WATER HAS REACHED OVER THE DOORSILL AND ENTERED THE
- 7 PASSENGER".
- 8 Page 3, line 11, strike "REPAIRED:" and substitute "REPAIRED OR
- 9 REPLACED:".
- 10 Page 3, line 17, after the period insert "THESE VEHICLES MAY NOT BE
- 11 ISSUED A CERTIFICATE OF TITLE, AND ANY TITLE SECURED IN THE
- 12 PURCHASE OF SUCH A VEHICLE IS TO BE SURRENDERED TO THE
- 13 DEPARTMENT, WHICH SHALL CANCEL THE VEHICLE IDENTIFICATION
- 14 NUMBER AND REMOVE THE VEHICLE FROM THE MOTOR VEHICLE SYSTEM.".
- 15 Page 5, after line 13 insert:
- 16 **"SECTION 3.** In Colorado Revised Statutes, 42-6-110 **add** (1.5)

1 as follows:

2 **42-6-110. Certificate of title - transfer.** (1.5) (a) IF AN INSURER,
3 AS DEFINED IN SECTION 10-1-102 (13), C.R.S., OR A SALVAGE POOL
4 AUTHORIZED BY AN INSURER IS UNABLE TO OBTAIN THE PROPERLY
5 ENDORSED CERTIFICATE OF OWNERSHIP OR OTHER EVIDENCE OF
6 OWNERSHIP ACCEPTABLE TO THE DEPARTMENT WITHIN THIRTY DAYS
7 FOLLOWING ORAL OR WRITTEN ACCEPTANCE BY THE OWNER OF AN OFFER
8 OF SETTLEMENT OF A TOTAL LOSS, THAT INSURER OR SALVAGE POOL MAY
9 REQUEST, ON A FORM PROVIDED BY THE DEPARTMENT AND SIGNED UNDER
10 PENALTY OF PERJURY, THE DEPARTMENT TO ISSUE A SALVAGE OR
11 NONREPAIRABLE TITLE FOR THE VEHICLE. THE REQUEST MUST INCLUDE
12 INFORMATION DECLARING THAT THE INSURER OR SALVAGE POOL HAS
13 MADE AT LEAST TWO WRITTEN ATTEMPTS TO OBTAIN THE CERTIFICATE OF
14 OWNERSHIP OR OTHER ACCEPTABLE EVIDENCE OF TITLE AND MUST
15 INCLUDE THE FEE FOR A DUPLICATE TITLE. THE FORM REQUESTING A
16 SALVAGE OR NONREPAIRABLE TITLE IS THE ONLY EVIDENCE REQUIRED TO
17 OBTAIN A SALVAGE OR NONREPAIRABLE TITLE.

18 (b) UPON RECEIVING THE FEE FOR A DUPLICATE TITLE AND THE
19 CERTIFICATE OF OWNERSHIP, OTHER EVIDENCE OF TITLE, OR A PROPERLY
20 EXECUTED REQUEST DESCRIBED IN PARAGRAPH (a) OF THIS SUBSECTION,
21 THE DEPARTMENT SHALL ISSUE THE SALVAGE OR NONREPAIRABLE TITLE
22 FOR THE VEHICLE."

23 Renumber succeeding sections accordingly.

24 page 7, line 4, strike "UPON THE SALE OF PARTS FROM A VEHICLE THAT IS".

25 Page 7, strike lines 5 and 6.

26 Page 7, line 7, strike "OWNERSHIP OF THE PART."
