After consideration on the merits, the Committee recommends the following:

HB15-1089 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 1 Amend printed bill, page 3, after line 3 insert:
- 2 "(c) A KEI VEHICLE IS NOT A MOTOR VEHICLE."
- 3 Page 3, line 14, after "EXPIRES" insert "THE EARLIER OF ANNUALLY OR"
- 4 Page 3, after line 18 insert:
- 5 "(c) WHEN REGISTERING A KEI VEHICLE, THE OWNER SHALL, IN
- 6 ACCORDANCE WITH SECTION 42-3-105, SHOW PROOF OF INSURANCE OR
- 7 SIGN A STATEMENT OF NONUSE."
- 8 Reletter succeeding paragraph accordingly.
- 9 Page 3, line 26, strike "THREE DOLLARS." and substitute "THE SAME AS
- 10 FOR CLASS C PERSONAL PROPERTY."
- 11 Page 5, line 24, strike "(1)"
- 12 Page 5, line 26, after the period add "THE DEPARTMENT SHALL TRANSFER
- 13 THE FEE TO THE STATE TREASURER, WHO SHALL CREDIT THE FEE TO THE
- 14 COLORADO STATE TITLING AND REGISTRATION ACCOUNT CREATED IN
- 15 SECTION 42-1-211 (2)."
- 16 Page 5, strike line 27.

1 Page 6, strike lines 1 through 5.

2 Page 8, before line 9 insert:

3 "SECTION 12. In Colorado Revised Statutes, 42-1-211, **amend**
4 (2) as follows:

5 **42-1-211. Colorado state titling and registration system.**

6 (2) There is hereby created the Colorado state titling and registration
7 account in the highway users tax fund for the purpose of providing funds
8 for the development and operation of the Colorado state titling and
9 registration system, including: Operations performed under article 6 of
10 this title; THE REGISTRATION OF KEI VEHICLES; and to cover the costs of
11 administration and enforcement of the motorist insurance identification
12 database program created in section 42-7-604. Moneys received from the
13 fees imposed by section 38-29-138 (1), (2), (4), and (5), C.R.S., and
14 sections 42-1-206 (2) (a), 42-3-107 (22), 42-3-213 (1) (b) (IV), ~~42-6-137~~
15 42-3-315, 42-6-137 (1), (2), (4), (5), and (6), and 42-3-304 (18) (d), as
16 well as any moneys received through gifts, grants, and donations to the
17 account from private or public sources for the purposes of this section,
18 shall be credited by the state treasurer to the Colorado state titling and
19 registration account. The general assembly shall appropriate annually the
20 moneys in the Colorado state titling and registration account for the
21 purposes of this subsection (2). If any unexpended and unencumbered
22 moneys remain in the account at the end of a fiscal year, the balance
23 remains in the fund and is not transferred to the general fund or any other
24 fund."

26 Page 10, after line 25 insert:

27 "SECTION 17. In Colorado Revised Statutes, 33-14.5-101,
28 **amend** (3) introductory portion, (3) (d), and (3) (g) as follows:

29 **33-14.5-101. Definitions.** As used in this article, unless the
30 context otherwise requires:

31 (3) "Off-highway vehicle" means ~~any~~ A self-propelled vehicle
32 ~~which~~ THAT is designed to travel on wheels or tracks in contact with the
33 ground, ~~which~~ is designed primarily for use off of the public highways,
34 and ~~which~~ is generally and commonly used ~~to transport persons~~ for
35 recreational purposes. "Off-highway vehicle" does not include: ~~the~~

- 2 (d) Golf carts CARS;
- 3 (g) MOTOR vehicles registered pursuant to UNDER article 3 of title
- 4 42, C.R.S."
