HB15-1043 be amended as follows, and as so amended, be referred to the Committee on Finance with favorable recommendation:

- 6 Page 10, line 19, strike "HOUSE BILL 15-____," and substitute "HOUSE
7 BILL 15-1043,".
- 8 Page 10, line 21, strike "~~shall~~ MUST" and substitute "shall".
- 9 Page 10, strike lines 22 through 25 and substitute:
10 "(c) NOTWITHSTANDING ANY OTHER PROVISION OF LAW, IF THE
11 DEFENDANT SATISFIES THE CONDITIONS DESCRIBED IN SUBPARAGRAPHS
12 (I), (II), AND (III) OF THIS PARAGRAPH (c), THE COURT MAY INCLUDE AS A
13 CONDITION OF PROBATION A REQUIREMENT THAT THE DEFENDANT
14 PARTICIPATE IN ALCOHOL TREATMENT. IF THE DEFENDANT'S ASSESSED
15 TREATMENT NEED IS FOR RESIDENTIAL TREATMENT, THE COURT MAY MAKE
16 RESIDENTIAL ALCOHOL TREATMENT A CONDITION OF PROBATION AND MAY
17 PLACE THE OFFENDER IN A COMMUNITY CORRECTIONS PROGRAM THAT CAN
18 PROVIDE THE APPROPRIATE LEVEL OF TREATMENT. THIS PARAGRAPH (c)
19 APPLIES ONLY IF:".

1 Page 13, line 8, strike "HOUSE BILL 15-____," and substitute "HOUSE BILL
2 15-1043,".

3 Page 13, line 18, strike "HOUSE BILL 15-____," and substitute "HOUSE

5 Page 13, strike line 25 and substitute "15-1043, AS ENACTED IN 2015:".

6 Page 19, after line 8 insert:

7 "SECTION 10. In Colorado Revised Statutes, 17-2-201, **add**
8 (5.9) as follows:

9 **17-2-201. State board of parole.** (5.9) AS A CONDITION OF
10 PAROLE OF EACH PERSON CONVICTED OF A FELONY DUI OFFENSE
11 DESCRIBED IN SECTION 42-4-1301 (1) (a), (1) (b), OR (2) (a), C.R.S., THE
12 BOARD SHALL REQUIRE THE PAROLEE TO USE AN APPROVED IGNITION
13 INTERLOCK DEVICE FOR THE ENTIRE PERIOD OF THE PERSON'S PAROLE.".
