After consideration on the merits, the Committee recommends the following:

HB15-1255 be amended as follows, and as so amended, be referred to the Committee of the Whole with favorable recommendation:

1 Amend printed bill, page 4, after line 26 insert:

2 "(D) A PROVISION THAT ANY ESTABLISHMENT DESCRIBED IN  
3 SUBPARAGRAPH (I) OF THIS PARAGRAPH (h) IS EXEMPT FROM THE  
4 REQUIREMENTS OF THE RULES ADOPTED PURSUANT TO  
5 SUB-SUBPARAGRAPHS (A) TO (C) OF THIS SUBPARAGRAPH (II) IF THE  
6 ESTABLISHMENT PROVIDES TO THE DEPARTMENT OF REVENUE A  
7 STATEMENT FROM THE OWNER OR OPERATOR OF EACH AUTOMATED  
8 TELLER MACHINE LOCATED WITHIN THE ESTABLISHMENT VERIFYING THAT  
9 THE MACHINE DOES NOT ACCEPT ELECTRONIC BENEFIT TRANSFER CARDS;  
10 EXCEPT THAT, IF ONE OR MORE VIOLATIONS OF SUBPARAGRAPH (II) OF  
11 PARAGRAPH (a) OF THIS SUBSECTION (2) OCCUR AT ANY SUCH  
12 ESTABLISHMENT, THE DEPARTMENT OF REVENUE MAY TAKE MEASURES TO  
13 PREVENT FUTURE VIOLATIONS, INCLUDING INCREASING PENALTIES FOR  
14 MULTIPLE VIOLATIONS."

15 Page 6, after line 17 insert:

16 "(D) A PROVISION THAT ANY ESTABLISHMENT DESCRIBED IN  
17 SUBPARAGRAPH (I) OF THIS PARAGRAPH (h) IS EXEMPT FROM THE  
18 REQUIREMENTS OF THE RULES ADOPTED PURSUANT TO  
19 SUB-SUBPARAGRAPHS (A) TO (C) OF THIS SUBPARAGRAPH (II) IF THE  
20 ESTABLISHMENT PROVIDES TO THE DEPARTMENT OF REVENUE A  
21 STATEMENT FROM THE OWNER OR OPERATOR OF EACH AUTOMATED

1 TELLER MACHINE LOCATED WITHIN THE ESTABLISHMENT VERIFYING THAT  
2 THE MACHINE DOES NOT ACCEPT ELECTRONIC BENEFIT TRANSFER CARDS;  
3 EXCEPT THAT, IF ONE OR MORE VIOLATIONS OF SUBPARAGRAPH (II) OF  
4 PARAGRAPH (a) OF THIS SUBSECTION (2) OCCUR AT ANY SUCH  
5 ESTABLISHMENT, THE DEPARTMENT OF REVENUE MAY TAKE MEASURES TO  
6 PREVENT FUTURE VIOLATIONS INCLUDING INCREASING PENALTIES FOR  
7 MULTIPLE VIOLATIONS."
