### **FY 2007-08 PRIMARY CARE FUND AWARD ANNOUNCEMENT**

The Department of Health Care Policy and Financing is pleased to announce the award decisions for FY 2007-08 under the Primary Care Fund. Award payments use provider's patient data from the previous calendar year. These payments are based on the percentage of medically indigent patients served by an individual provider in proportion to the total number of medically indigent patients served by all health care providers who qualify for moneys from this fund

The total funds available for FY 2007-08 are anticipated to be \$32,365,298. The award percentages by provider are as follows:
