INSTRUCTIONS AND INFORMATION

APPLICATION Application shall be made by each individual, corporation, partnership, association, government agency, or other legal entity in business as a seed labeler, custom seed conditioner, farmer seed labeler and/or retail seed dealer. The deadline date for application shall be the last day of February, except for those persons who were not registered in the previous year. See above for the registration fees.

REGISTRATION FEES The registration fees shall be charged in accordance with the fee schedule above, except that each person who was registered in the previous year and fails to apply by the last day of February shall pay double the prescribed fee.
