FEE SCHEDULE
INSPECTION FEES

CATTLE

\$.55 per head inspection fee (country)
\$10.00 service charge fee - per stop
(all cattle not going direct to slaughter)
\$15.00 minimum fee - per stop
(all cattle going direct to slaughter)
\$.53 per head - fat cattle to slaughter
\$.50 per head - fat cattle (over 500 head)
\$10.00 per head - show cattle travel permit
\$1.00 per head rodeo cattle travel permit
\$.55 per head rodeo stock in-state travel
\$.46 per mile - no brand calf mileage

HORSES

\$1.00 per head inspection fee (country)
\$2.00 per head inspection fee (public livestock market)
\$15.00 minimum fee per owner
\$25.00 per head - travel permit

SHEEP

\$.40 per head inspection fee (upon request)
\$15.00 minimum fee per stop

CERTIFIED FEEDLOT PROGRAM

\$1,000.00 per feedlot - good for one year (July 1st - June 30th)
\$.38 per head - cattle leaving feedlot going directly to slaughter

PROMOTION FEES COLLECTED FOR COLORADO BEEF COUNCIL AND
COLORADO HORSE DEVELOPMENT AUTHORITY

CATTLE

\$1.00 per head - beef council fee

HORSES

\$3.00 per head - horse promotion

HIDE INSPECTION FEES

\$.25 per head inspection fee
no charge for hide releases

FEE WAIVER

\$50.00 per application (good for period of two calendar years)
\$10.00 service charge for each stop (collected upon inspection of livestock)

BRAND RECORDING AND ASSESSMENT FEES

\$50.00 new brand application initiation fee
\$275.00 - 2007 assessment fee on brands - through December 31, 2011 - amount includes the late fees
\$50.00 transfer fee per brand
\$50.00 fee per brand for lease agreements - through December 31, 2011
\$1.00 fee - certified copy of brand deed
\$30.00 per book for available 1997, 2002 and 2007 Colorado brand books

LOST INSPECTION CERTIFICATE

\$40.00 per hour research fee for duplicate inspection certificates (30 minute minimum)

ALTERNATIVE LIVESTOCK FEES

\$300.00 maximum license fee - one year September through August
\$15.00 service charge fee per owner
\$5.00 per head inspection fee
\$1.00 per head inspection fee at alternative livestock sales
\$10.00 per head - travel permit - good one year from date of issue

SALE BARN FEES

\$100.00 license for sale barns - one year period May 1st to April 30th

SLAUGHTER PLANT FEES

\$50.00 Class I license (1-1000 head per year) - one calendar year
\$75.00 Class II license (1001-5000 head per year)
\$100.00 Class III license (5001 or more head per year)
Additional fees will be added by the Ag Commission for the next license period.

LAW BOOK

\$10.00 per book for the Colorado livestock statutes booklet
