Dear brand owner or lessee:

The enclosed lease agreement form must be completed any time a Colorado Brand is leased to another party. The fee to record a lease agreement is \$50.00 per agreement and must be recorded with this office. The term of the brand lease may begin on January 1, 2007 (or current date) and will automatically terminate on December 31, 2011 or on an earlier date if specified in the lease agreement. The 2007 assessment fee must be current and paid on the brand.

All recorded owner(s) of this brand must sign as lessor(s) of the brand and all lessor signatures must be **notarized** properly. The back of the form may be used. All owners must sign the form exactly as their name appears on the brand recording. If the brand is recorded in a company, ranch, partnership or corporation name, this office may require two signatures as owner(s) of this brand. Check with this office if you have any questions concerning who may sign for the company, ranch, partnership or corporation.

The lessee(s) of the brand must also sign the agreement. If you want to list the lessee of the brand as a **professional corporation, incorporation, limited partnership** or general partnership, this office will require certification of filing with the Secretary of State's office. **Certification** will consist of a certificate of good standing, a certificate of existence or a certified copy of the articles of incorporation. This office will then require the signature of the recorded president or secretary for that professional corporation, incorporation, limited or general partnership. This office will accept a copy of the partnership agreement if the brand is to be leased to a partnership, and we will require the signature of the general partner as the lessee on the form. In the event of a ranch or company name, sole proprietorship or any other business name that is not filed with the Secretary of the State's office, the lessee of the brand must be listed in the individual's name or names "doing business as" the ranch name or company name.


Please complete the remainder of the form and return to this office along with the \$50.00 lease recording fee and any additional documents that are required. Please mark if this brand is to be used only by the lessee during the term of the lease or if the lessor may also use this brand.

This office will process and record the lease agreement and return a certified copy to the lessee. The **lessee must** present the certified copy to the brand inspector each time livestock is sold or transported. If you have any questions, please contact the Denver Brand office at 303.294.0895.
