This Addendum dated this 2nd day of November, 2007 is attached to, and made a part of, the Statewide Basic Ordering Agreement entered into on the 15th day of April, 2004 (hereinafter the "Agreement") by and between Entities listed on attached Schedule A. (hereinafter "Vendor") and the State of Colorado Travel Management Program ("Customer").

The Agreement is hereby amended as set forth in this Addendum:

The following provisions shall be added to the Agreement:

- 1.) For business rentals (excluding 12 and 15 Passenger vans) originating in the State of Colorado only, authorized drivers shall include properly licensed Customer employees age eighteen (18) years and older.
- 2.) For business rentals the class of vehicles shall include:
 - a. 12 Passenger Van
 - i. The Vendor shall provide collision damage waiver coverage as a part of the state rate on 12 passenger vans.
 - ii. The Vendor shall provide \$600,000 Liability insurance coverage as a part of the state rate on 12 passenger vans.
 - iii. The Vendor shall provide unlimited miles for 12 passenger van rentals.
 - iv. The Vendor shall provide unlimited miles for 12 passenger van rentals
 - v. Rental rates: \$100/day; \$600/week; \$2,300/month.

The terms and conditions of the Agreement, except as duly modified by this and previous amendments, if any, remain in full force and effect.
