- 1.) Page 8, Section III, B. Vendor Terms and Conditions/Forms  
Verify if your company requires renters to complete any supplemental terms and conditions and/or separate forms? (e.g. Master Rental Agreement). If so, please provide a copy to the State Travel Manager.
- 2.) Page 11, Section III, L. Leisure Usage of Contract  
The State now prohibits the use of the Travel Card for personal or leisure travel. Nonetheless, the State does allow vendors to extend specific prices and rates to State employees for personal or leisure use. Advantage will extend the State rates to leisure rentals, excluding insurance. Additionally, Advantage will combine all leisure and business travel for the quarterly volume rebate to the State Travel Management Program.
- 3.) Page 11, Section III, N. Insurance Refunds - Administrative/Recovery Fee  
Advantage agrees to not sell insurance to a state traveler on business use unless the traveler has a waiver from the State Travel Management Program. Also, Advantage agrees to provide the State Travel Management Program a quarterly report that identifies the number of instances unnecessary insurance was charged along with the \$30 administrative/recovery fee per incident payment to:
