

*Example of Verbal Amendment to HB 13-1502*

"I move to strike "JANUARY 1, 2014," on page 5, line 18, and change the date by which PIs must be licensed to "JULY 1, 2013,".

Possible script arguments for & against amendment:

***For:*** *We need to get this profession under control and start getting the good PIs licensed as soon as possible. This will help clean up the profession and boost public confidence in private investigators.*

***Against:*** *The director of the division tells me that there is no way the division can have the rules in place to start licensing PIs by this July 1. They need time to hire the necessary personnel to oversee this regulatory function and then work with stakeholders in the rule-making process. The director has indicated that January 1, 2014, is the soonest the division would be able to implement this bill.*
