Required to be Submitted with this Form					
For ALL EXTENSIONS: If the state which the vehicle is currently in requires emission testing, you must submit a PASSING emissions test from the state with your application (except for reason "D"). If an emission test is not required, you must submit a vehicle identification number (VIN) verification from the state the vehicle is currently in, to be completed by law enforcement ONLY, with your application.

Reason for Extension

A - ****Out of State Student**

Vehicle owner and/or immediate family member who is out of state attending school on a full-time basis.

B - ***Out of State Military**

Vehicle owner and/or spouse who is out of state on **active** duty in a branch of the United States military. Military individual **must** be the owner or co-owner of the vehicle. For the purpose of this form, Military Police are recognized as law enforcement.

C - **Seasonally Out of State**

Vehicle owner who spends a portion of the year (less than 12 months) and returns the vehicle to Colorado **every** year. **It is strongly recommended that the vehicle owner change the registration cycle to coincide with when the vehicle is in Colorado to avoid Emission Extensions every year.**

D - **Vehicle Disabled Out of State**

Vehicle owner and/or immediate family member who had the vehicle out of state when it became disabled due to a vehicle accident or engine trouble. **Must provide receipts from the repair shop or body shop where services were provided, and or any accident report if applicable.**

E - **Working Out of State**

Vehicle owner and/or immediate family member who is working in any capacity out of state. **NOTE: Some states require registration if individual is working in their state (i.e. Alabama, Alaska, Arizona, California, Florida, Louisiana, Montana, Nevada, North Dakota, Texas, Utah and Wyoming).**

F - **Temporarily Out of State**

Vehicle owner and/or immediate family member who is temporarily out of state for family emergency, caring for a sick relative, settling family estate, etc. **This category should not be confused with "Working Out of State".**

Lower Portion of Form

The **Name, Address, City, County, State, ZIP, and Contact Phone # of Out of State Contact** is required for verification (i.e. school, school's complete address, registrar's phone number), (i.e. military installation, complete address, main branch phone number), (i.e. repair shop, shop's address and phone number), etc. Under "Name of Out of State Contact", include the name of the individual if other than the registered vehicle owner.

***Military ID #** is required for all individuals requesting as extension based on "**Out of State Military**".

****Student ID #** is required for all individuals requesting as extension based on "**Out of State Student**".

Month/Year of Return to Colorado is mandatory!

Out of State Address to mail registration to is necessary to mail the renewal tabs and registration to where the vehicle is located out of state. Renewal tabs and registration **WILL NOT** be mailed to a "Colorado" address or handed to the individual over the counter.

Important Reminders

- **Completed ORIGINAL application must be submitted to your LOCAL COLORADO COUNTY CLERK'S MOTOR VEHICLE OFFICE with your vehicle license renewal notice, proof of insurance and payment. A completed application does not assure automatic approval. Further information MAY be required in order to have the request approved.**
- All areas of the application must be filled out or the application will be returned "INCOMPLETE" or "DENIED". This may result in a delay in your license plates being renewed.
- Vehicles registered on this extension application using a VIN Verification, **MUST** be emission tested within 15 days upon returning to Colorado.
- Owners of vehicles that do not comply with the inspection requirements upon return to Colorado are subject to penalties as defined in 42-4-313 C.R.S.
- Once the vehicle returns to Colorado, the vehicle owner **MUST** contact his or her County Clerks Office to have his or her registration mailing address changed back to a Colorado address.
