CACFP: 1) Visits providers at least three times per year to provide information on feeding children; 2) Helps the provider comply with food program requirements; and, 3) Provides at least one food program training during the year at no charge to the child care provider. The program is administered by the Colorado Department of Public Health and Environment, Child and Adult Care Food Program (CDPHE-CACFP), and is funded by the U. S. Department of Agriculture.
