

Appendix C3 Footnote References for Foreign Per Diem Rates Effective October 1, 2011

FOOTNOTES:

1/ The per diem rates for Afghanistan listed in the main body of this supplement apply to travelers obtaining lodging on USG civilian compounds or residing with the US military. In accordance with FTR Appendix B, the M&IE is reduced for meals provided by the USG. If all meals are provided by the USG, the Incidental rate for Kabul is \$6. The maximum per diem rates that apply to travelers using local hotels and/or restaurants are: Lodging \$102, M&IE \$100 for Kabul, Lodging \$99, M&IE \$40 for Herat, and Lodging \$51, M&IE \$50 for Other, Afghanistan.

4/ The per diem rates listed for Iraq in the main body of the per diem supplement apply to travelers obtaining lodging on USG civilian compounds or residing with the U.S. military in Iraq. In accordance with FTR Appendix B, the M&IE must be reduced for all meals provided by the USG. The maximum per diem rates that apply to travelers using local hotels and/or restaurants are: Baghdad: Lodging \$100, M&IE \$54; Erbil: Lodging \$211, M&IE \$65; Other, Iraq: Lodging \$73, M&IE \$48.

5/ San Salvador includes the San Salvador International Airport area of Comalapa.

/6 The per diem rates for Lebanon listed in the main body of this supplement apply to travelers obtaining lodging on USG civilian compounds. The maximum per diem rates that apply to travelers using local hotels and/or restaurants are: Lodging \$165, M&IE \$75 for Beirut and Other, Lebanon.

/7 Effective August 1, 2011: Not in use as of August 1, 2011. Previously stated: These rates were established for Athens, Greece effective June 1, 2011, in connection with the Special Olympics World Games, hosted by Athens from June 15 thru July 9, 2011, and where more than 7,500 Special Olympics Athletes from 185 nations will compete in 22 sports. These rates will be terminated from the Supplement effective August 1, 2011.

/8 Effective September 1, 2011, These rates were established for Auckland, Wellington and Other, New Zealand effective September 1, 2011, in connection with the Pacific Island Forum (PIF) and Rugby World Cup (RWC), hosted by New Zealand. The PIF is an inter-governmental organization that aims to enhance cooperation between the independent countries of the Pacific Ocean. RWC - New Zealand promised a 'stadium of four million' and is now preparing to become a nation of four million hosts when it welcomes 20 competing nations and around 85,000 international rugby fans for Rugby World Cup 2011. These events are scheduled to be held from September 1 and culminating the weekend of October 23,
