Rules

A. Initial Approval Agenda

Document 01, MSB 18-01-09-A, Revision to the Medical Assistance Rule concerning Long-Acting Reversible Contraceptives, Section 8.300.5

Russell Zigler, Operations Division, and Melanie Reece, Benefits Management Division, Raine Henry, presented the rule and provided a background of how the payment is calculated for Long-Acting Reversible Contraceptives. Federal approval now has the payment exclude the cost of the LARC device. The cost is on a fee schedule, not spread over all hospitals.

Board Discussion – Board discussion included this change only applying to Medicaid members.

Document 02, MSB 19-09-05-A, Revision to the Medical Assistance Act Rule concerning Outpatient Speech Therapy, Section 8.200.3.D.2

Russell Zigler, Operations Division, and Alex Weichselbaum, Benefits Management Division, presented the rule and explained the rule allows flexibility in how documentation is submitted to the Department, provided it has the necessary elements.

Board Discussion – Board discussion included a review of the outpatient speech therapy benefit history. A dialogue of how a review of a benefit is initiated was discussed.

Public Testimony – Kyle Delahanty, Speech Language Pathology – Over the age of 21 drop in coverage is not good, there is still a need.

Document 03, MSB 19-12-06-B, Revision to the Medical Assistance Act Rule concerning Community Mental Health Centers, Section 8.750.3.B

Russell Zigler, Operations Division, and Alex Weichselbaum, Benefits Management Division, presented the rule and explained the proposed revisions to the rule removes the state limit of visitations. The rule will now match policy.
