Known Issue

Durable Medical Equipment (DME) Supply Claims Suspending Explanation of Benefits (EOB) 3530

Claims billed with procedure code E1399 and Modifier U1 for dates of service (DOS) 04/07/23 - 06/16/23 are suspending for EOB 3530 - "There is no rate on file for the date of service. Charges cannot be processed."

This only impacts claims with both E1399 and Modifier U1. Claims with E1399 and no modifier are processing normally.

A resolution to this issue is in process.

Affected claims will be reprocessed.

Durable Medical Equipment (DME) Supply Claims Suspending Explanation of Benefits (EOB) 2861

Claims were suspending for Explanation of Benefits (EOB) 2861 - "No Rate on File for the Date(s) of Service." A secondary issue was affecting claims. Claims were in a suspended status for the <u>following codes</u>.

Claims for procedure codes E0118, E0274, E0370, E0565, E0785, E0786, E0850, E0856, E0930, E0936, E0958, E0959, E0967, E0968, E0969, E0970, E0980, E0983, E0984, E0986, E0988 were suspending for Explanation of Benefits (EOB) 2861 - "No Rate on File for the Date(s) of Service."

Some Durable Medical Equipment (DME) Supply Claims Paying at Incorrect Rate

Some DME claims with procedure codes A4267, A4268, A4269, A4351, A4352, E1130, E1140, K0739 and K0740 were paying at the old default rate instead of the DME rural and non-rural rate.

Affected claims will be reprocessed.

Durable Medical Equipment (DME) Supply Claims Paying at Incorrect Rate

Some DME claims with procedure code E2512 were paying at the incorrect rate of \$501.57. The correct rate is \$4,465.18.

DME claims with procedure code A9274 and U1 modifier were paying at a set rate. This code should be manually priced when the U1 modifier is used.

Affected claims were reprocessed 04/28/23.

Durable Medical Equipment (DME) Supply Claims Paying at Incorrect Rate

Some DME claims with dates of service after 07/01/22 were paying at the old default rate instead of the DME rural and non-rural rate.
