AUDIENCE CSU EXTENSION AGENT QUARTERLY REPORT

Bruce Fickenscher was present to update the board on the quarterly CSE report. The period highlighted was July to September, 2016. Among the highlights were:

Crowley County Days was a success. General exhibit numbers were on the rise this year and ranged from cake decorating to gardening and rocketry. The dog show was a great success as were the poultry and rabbit shows.

Wheat collaborative on farm test has been conducted.

Southeast Colorado has two agents certified as trainers for the beef quality assurance (BOA) program. Bruce Fickenscher has completed the Train the Trainer program in September. Colorado BOA program is sponsored by the Colorado Beef Board with beef check off dollars.

Pedal the Plains was a great success. This was in conjunction with local volunteers and the Governors Office of Economic Development.

A discussion was held regarding what course of action could be done regarding the abandoned drainage ditches and their maintenance thereof. The problem of fire mitigation was discussed and the possibility of a public meeting to address the issue. County will confer with drainage companies and county fire chief and seek advice from the county attorney.
