1033 Equipment Available for Transfer—Peacekeepers, Humvees, and Rifles

Two [Peacekeeper Armored Personnel Carriers](#) are available for transfer through the 1033 LESO Program. These trucks feature armor plating and bullet-resistant glass to keep officers safe. Both trucks run and drive, are considered in good condition, and were built in the 1980s.



We have a large quantity of both [M14 and M16 rifles](#) available for transfer through the 1033 LESO Program. Overall, the rifles are in good, usable condition, ready to be issued to officers in your agency. Rifles are available in multiple locations around the state.

Two [Humvees](#) are available for transfer through the 1033 LESO Program. Both have been with an agency for several years and are in running condition.

Contact our office to start the transfer process if you are interested in acquiring any of this or other equipment.

1033 LESO Annual Inventory Certification Complete

Congratulations to everyone for completing the annual inventory certification process on time! Thanks for all of your hard work to meet the deadline.

Notification that all of the participating agencies in Colorado met the deadline has been sent to the Governor.

This is an opportunity to share your accomplishment with your community. A press release or an article in the local newspaper could describe the valuable

items that your agency has acquired at no cost.

Completing the annual inventory certification demonstrates your agency's commitment to accountability and transparency with the program.

In addition, a story can illustrate the way your agency is using that equipment to benefit the community.

There are a couple of ways to access the list of the equipment your agency has from 1033:

- Scroll to the very bottom of the [DLA E-Reading Room](#) page. Click the "[Alaska-Wyoming and US Territories](#)" link to download a spreadsheet. Go to the "Colorado" tab and scroll to your agency.
- Or, go to [FAMWEB](#) and log in. Go to LESO FEP-MIS, and then Queries and Reports. In the pop-up window, choose "Property Book—Local Use" and search for your agency.

1033 LESO Armored Humvees Available

Does your agency need an armored vehicle? Does your agency also need 4-wheel drive capability?

1033 LESO will release good-condition armored HMMWVs soon. These trucks were built with armor by the manufacturer and have beefier suspension, motor, and brakes to handle the extra weight.

Your agency will be responsible

for the cost to transport a truck from KY, but otherwise there is no cost to acquire one.

To get your agency on the request list, complete and submit the following paperwork:

- [Civilian Governing Body Authorization \(for Police and Marshals\)](#)

- [Civilian Governing Body Notification \(for Sheriffs\)](#)

Be sure to note specifically that you are requesting an armored Humvee. All forms must be signed by the Chief Law Enforcement Officer (Chief or Sheriff).

1122 Program Vehicle Ordering in the New Year

As fresh agency budgets come available with the new year, this is the time to think about ordering new vehicles through the 1122 Federal Purchasing Program.

Through the 1122 Program, local governments engaged in drug prevention, homeland security, and emergency response can **purchase new vehicles using the prices**



es and terms negotiated by the federal government.

These vehicles are custom-built to your specifications, which means that they usually take about three months to be delivered. That makes the new year a great time to order vehicles to ensure they arrive be-

fore the end of the year.

Head to [GSA AutoChoice](http://GSA_AutoChoice) to build out and price a vehicle. If you need to set up a new account, use these codes:

- Agency Code 21
- Bureau Code 44

Contact our office when you are ready to place an order.

Remember also to check out the deals available through the [State Price Agreements](#). Every unit of local government is eligible to purchase new vehicles using the prices and terms negotiated by the state of Colorado.

Depending on the vehicle and specifications, sometimes 1122 is a better deal, while other times the State Price Agreements are better.

The Law Enforcement Support Office (LESO) within the Department of Defense (DoD), Defense Logistics Agency, facilitates the 1033 LESO program. This program allows transfer of excess DoD property that might otherwise be destroyed to law enforcement agencies across the United States.

Section 1122 of the National Defense Authorization Act authorizes state and local agencies to purchase equipment and supplies in support of counter-drug, homeland security, and emergency response activities through federal sources of supply. Agencies can take advantage of the volume buying power of the Federal Government for low prices.


