

**NOTICE OF GENERAL MUNICIPAL ELECTION**  
**Pursuant to Colorado Revised Statutes, Section 31-10-501(1)**  
**and 31-10-501(2) Notice is hereby given that:**

**The Town of Ignacio will hold a regular municipal election on Tuesday, April 3, 2018 at 570 Goddard Avenue in Ignacio, Colorado. The Polls will be open between the hours of 7AM and 7PM. Every person who is a citizen of the United States, has attained the age of eighteen, has resided within the town limits of Ignacio, Colorado for at least twenty two days immediately preceding the election, has met the qualifications to register to vote at this residence with the La Plata County Clerk and Recorder, and has registered to vote, shall be eligible to vote at this election.**

**BALLOT QUESTION 1.A**

SHALL THE TOWN OF IGNACIO'S TAXES BE INCREASED \$225,000.00 IN 2019 (FIRST FULL YEAR OF SUCH TAX INCREASE), AND BY WHATEVER AMOUNTS ARE RAISED ANNUALLY THEREAFTER, BY IMPOSING, COMMENCING JULY 1, 2018, AN ADDITIONAL ONE PERCENT (1%) SALES TAX; PROVIDED THAT THE ADDITIONAL ONE PERCENT SALES TAX AUTHORIZED HEREIN SHALL BE APPROVED AND PLEDGED TO THE TOWN OF IGNACIO'S CAPITAL IMPROVEMENTS PROJECTS FUND AND TO BE USED SOLELY FOR CAPITAL IMPROVEMENTS PROJECTS APPROVED BY THE BOARD OF TRUSTEES; AND SHALL THE TOWN'S EXISTING SALES TAX, INCLUDING ANY TAX INCREASE APPROVED HEREIN, AND INCLUDING SUCH INCREASES IN REVENUES AND ANY INVESTMENT INCOME THEREON, BE COLLECTED AND SPENT BY THE TOWN AS A VOTER APPROVED REVENUE AND SPENDING CHANGE, WITHOUT REGARD TO ANY SPENDING, REVENUE RAISING OR OTHER LIMINATION CONTAINED IN ARTICLE X, SECTION 20 OF THE COLORADO CONSTITUTION AND ANY OTHER LAW, AND WITHOUT LIMITING IN ANY YEAR THE AMOUNT OF OTHER REVENUES THAT MAY BE COLLECTED AND SPENT BY THE TOWN?
