This application is for a Special Use Permit to operate a livestock truck washing and cleaning facility in the "A" Agriculture Production Zone District. #### Consideration of Approval – 2019 MORGAN COUNTY FEE SCHEDULE

Morgan County Administrative Services Manager Karla Powell presented to the Board for approval, the 2019 Morgan County Fee Schedule. Ms. Powell stated she made contact with all departments and indicated there were only minor changes this year, indicating those changes in the Solid Waste Management fee schedule, and a change in the Sheriff's Office, whereas there is an additional fee being implemented, and a clarification of an additional fee as well as a change in recorded documents.

Commissioner Becker made the motion to approve the 2019 Morgan County Fee Schedule as outlined by Morgan County Administrative Services Manager Karla Powell and as printed with Commissioner Arndt seconding the motion and motion carried 3-0.

# Consideration of Approval – VEHICLE PURCHASE – State Bid #113483, Admin Trip 2019 Chevrolet Impala LS

Morgan County Public Works Director Bruce Bass presented to the Board for approval, State Bid #113483, for the purchase of one 2019 Chevrolet Impala LS with John Elway Chevrolet. Mr. Bass stated the purchase price of the vehicle would be \$21,457.00. Mr. Bass explained this on the replacement scheduled and is a budgeted item for 2019 and is for the Administration Trip vehicle.

Commissioner Becker asked if the County is only accepting state bids at this time or is the County bidding with other local vendors, with Mr. Bass stating typically the County is utilizing the state bid process given the County is an arm of the state, and the volume of pricing, the pricing seems to be best versus the local vendors. He stated it has been some time since it has been checked with local vendors but in the past they were not able to compete. Commissioner Becker stated that taking the vehicles we look at and group them together at one time and allow the local vendors to bid on them, would be a great idea, to allow them to have the opportunity to bid. Mr. Bass stated in order to follow that process, it could be put together at the time of budget preparation, but the problem is it would have had to be completed prior to this time of year, and sees an issue with having to have an approved budget, and asked about having the authority to do so without having the funds approved for the next year's budget. Commissioner Becker stated he does understand and does like to be able to provide the local vendors the opportunity the chance to bid on these types of purchases. Mr. Bass stated he would be happy to look further into working out a process that would work in conjunction with the budget cycle. Commissioner Arndt stated he has the same mindset as to allowing the local vendors to have the option to participate in the bidding process, stating it has been many years since it has been done. Further discussion followed as to allowing the local vendors an opportunity to bid, in finding a way for them to participate in these purchases, with drop shipping of the vehicles at a local dealer mentioned. Mr. Bass stated the state bid process now discourages that procedure, feeling that is giving the local companies an advantage over what should be allowed. Chairman Zwetzig stated that the local vendors are eligible and capable to submit pricing through the state bid with Mr. Bass stating that was correct. Mr. Bass noted the County does interact with the local businesses regarding repair services and in ordering of necessary parts and equipment.

Commissioner Arndt made the motion to approve State Bid #113483, for the purchase of one 2019 Chevrolet Impala LS in the amount of \$21,457.00 from John Elway Chevrolet as presented by Morgan County Public Works Director Bruce Bass noting the conversation held in regards to the ability for local vendors to submit bids for these types of purchases. Chairman Zwetzig seconded the motion. The motion carried 2-1 with Commissioner Becker the dissenting vote.

### Consideration of Approval – VEHICLE PURCHASE – State Bid #113488, DHS 2019 Dodge Caravan

Morgan County Public Works Director Bruce Bass presented to the Board for approval, State Bid #113488, for the purchase of one 2019 Dodge Caravan from Larry H. Miller. Mr. Bass stated the purchase price of the vehicle would be \$22,136.00. Mr. Bass explained this on the replacement scheduled and is a budgeted item for 2019 and is for the DHS.

Commissioner Arndt made the motion to approve State Bid #113488, for the purchase of one 2019 Dodge Caravan in the amount of \$21,136.00 from Larry H Miller as presented by Morgan County Public Works Director Bruce Bass. Chairman Zwetzig seconded the motion and motion carried 2-1 with Commissioner Becker being the dissenting vote.

### Consideration of Approval – VEHICLE PURCHASE – State Bid #113488, Jail Transport 2019 Dodge Caravan

Morgan County Public Works Director Bruce Bass presented to the Board for approval, State Bid #113488, for the purchase of one 2019 Dodge Caravan from Larry H. Miller. Mr. Bass stated the purchase price of the vehicle would be \$24,022.00. Mr. Bass explained this on the replacement scheduled and is a budgeted item for 2019 and is for the Jail Transport.

Commissioner Arndt made the motion to approve State Bid #113488, for the purchase of one 2019 Dodge Caravan in the amount of \$24,022.00 from Larry H Miller noting the difference in pricing is due to the additional parts necessary for the jail transport vehicle as presented by Morgan County Public Works Director Bruce Bass. Chairman Zwetzig seconded the motion and motion carried 2-1 with Commissioner Becker being the dissenting vote.

# Consideration of Approval – VEHICLE PURCHASE – State Bid #113488, Investigator 2019 Dodge Durango AWD Pursuit

Morgan County Public Works Director Bruce Bass presented to the Board for approval, State Bid #113488, for the purchase of one 2019 2019 Dodge Durango AWD Pursuit through Larry H. Miller. Mr. Bass stated the purchase price of the vehicle would be \$32,673.00. Mr. Bass explained this on the replacement scheduled and is a budgeted item for 2019 and is for the Investigator explaining the vehicle it is to replace is not set to expire on the replacement schedule but is a budgeted item.

Commissioner Becker asked Mr. Bass the question when they are looking at the specialty vehicles being purchased for the Sheriff's Office if the local vendors have the ability to place the order for these specialty vehicles with Mr. Bass stating they do have the ability to order these vehicles using the same codes with the package included. He also stated there is a delete package on the vehicle itself, and this is a state bid with it being built through the factory and the factory uses aftermarket vendor for the builds, stating the County is currently using a vendor located in Greeley explaining that Wireless Advanced as being the vendor and that allows for consistency in the parts being used and allows for reusing the parts which then reduces the costs in any rebuilds that may be necessary.

Commissioner Becker asked if the computer packages are being placed in the patrol vehicles, with Mr. Bass stating fleet does not install any of the equipment and stated that is the responsibility of the Sheriff's Office, and will have that part of the installation of the builds, but do not pay for those items, explaining the procedures that are being used. Commissioner Becker noted on his no votes for these vehicles, stating this may not be the best price out there but did not have the ability to review these bids prior to them being presented, and appreciates the work done by the fleet department, and feels the dissenting vote is the best at this time, given he was not able to have the information available.

Commissioner Arndt made the motion to approve State Bid #113488, for the purchase of one 2019 Dodge Durango AWD Pursuit in the amount of \$32,673.00 from Larry H Miller noting the difference in pricing is due to the additional parts necessary for the patrol vehicle, as presented by Morgan County Public Works Director Bruce Bass. Chairman Zwetzig seconded the motion and motion carried 2-1 with Commissioner Becker the dissenting vote.

Chairman Zwetzig stated he believes the comments made by Commissioner Becker are well taken and the Board will look into the matter further.

### Consideration of Approval – BID AWARD – RFP 2018-1220-003 – Fuel Filters

Morgan County Public Works Director Bruce Bass presented to the Board for approval Bid Award RFP 2018-1220-003 Fuel Filters. Mr. Bass stated he received nine actual returns in response to this bid process, one from Parts Smart Carquest for Carquest filters, Sailsbery Supply for Baldwin filters, Central Auto Parts for NAPA filters, MHC Kenworth - Greeley for Fleetguard filters, Transwest Truck for Baldwin filters, US Distributing Inc. for AC Delco filters, O'Reilly Auto Parts for Wix filters, A&A Auto Parts Stores for WIX filters and Western Automotive Warehouse Distributors for Ecogard filers. Mr. Bass outlined his bidding procedures in detail and further summarized the individual bids submitted from each vendor. Mr. Bass stated that the bid will be for annual supply for automotive filters for the period of January 1, 2019 through December 31, 2019. At this time Mr. Bass recommended the bid be awarded to Central Auto in the amount of \$572.09 for the filters as submitted indicating this vendor did submit the lowest bid.

Chairman Zwetzig asked if the filters that have been bid if he considers them comparable products, with Mr. Bass explaining they are paired as close to OEM as possible and believes they do meet the requirements, stating that the WIX filters have been used, Baldwins have been used and have had no issues, the Ecogard has not been used, so has no knowledge. Chairman Zwetzig stated in comparing numbers he wants to be sure that quality is being compared as well and Mr. Bass stated he has no concerns in regards to the quality of the filters being recommended.

Commissioner Becker made the motion to approve Bid RFP 2018-1220-003 Fuel Filters to Central Auto for the period of January 1, 2019 through December 31, 2019 in the amount submitted, \$572.09 as recommended by Morgan County Public Works Director Bruce Bass and authorized the Administrative Services Manager to execute the necessary contract to be ratified at a later date with Commissioner Arndt seconding the motion. At this time motion carried 3-0.

### Consideration of Approval - BID AWARD - RFP 2018-1220-001 Stationery Bid

Morgan County Administrative Services Manager Karla Powell presented to the Board for approval, the RFP 2018-1220-001 Stationery Bid. Ms. Powell stated that they received five bids bid from Centennial Printing in the amount of \$42,979.32, DocuMart in the amount of \$36,830.89, Color-Pro in the amount of \$71,075.92, One Source in the amount of \$30,602.10 and Impressions By Bird in the amount of \$30,370.00. The contract will be from January 1, 2019 through December 31, 2019. At this time, Ms. Powell recommended the bid be awarded to Impressions By Bird, the local vendor.

Commissioner Arndt made the motion to approve award the RFP 2018-0220-001 Stationery Bid to Impressions By Bird in the amount of \$30,370.00 noting this is the one procedure that is statutorily required to be completed annually and authorized the Administrative Services Manager to execute the necessary contract to be ratified at a later date. Commissioner Becker seconded the motion and motion carried 3-0.

### Consideration of Approval – BID AWARD – RFP 2018-1220-002 Jackson Lake Water (1) Share

Morgan County Administrative Services Manager Karla Powell presented to the Board for approval, the RFP 2018-1220-002 Jackson Lake Water (1) Share as a lease. Ms. Powell stated that they received only one bid from Fort Morgan Water Company, Ltd in the amount of \$500.00. Ms. Powell stated Fort Morgan Water Company, Ltd. has leased this share in the past.

Commissioner Becker made the motion to approve award the RFP 2018-1220-002 Jackson Lake Water (1) Share Bid Award in the amount of \$500.00 for the term of January 1, 2019 through December 31, 2019 to Fort Morgan Water Company, Ltd as recommended by Morgan County Administrative Services Manager Karla Powell and authorized the Administrative Services Manager to execute the necessary contract to be ratified at a later date. Commissioner Arndt noted this agreement will be in the form of a lease agreement. Commissioner Arndt seconded the motion and motion carried 3-0.

#### **COUNTY OFFICIAL AND DEPARTMENT HEAD REPORTS**

Commissioners reviewed the calendar dated January 4, 2019 through January 15, 2019 with changes.

Public Works Director Bruce Bass provided an update as to the workings of the Fleet/Road/Bridge Department.

Commissioner Arndt at this time welcomed Commissioner Jon Becker back to his seat as County Commissioner and looks forward to making Morgan County great. Commissioner Becker thanked Commissioner Arndt stating he is very happy to be back in this seat as Commissioner for District 2 and feels this will be a great opportunity to work with the elected officials, County employees and in serving the citizens of Morgan County.

Being no further business the meeting was then adjourned at 10:32 a.m.
