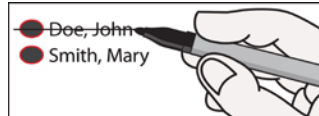
INSTRUCTIONS TO VOTERS:

To vote for a qualified write-in candidate, write the person's name in the blank space provided and FILL IN THE OVAL to the left.

WARNING: Any person who, by use of force or other means, unduly influences an eligible elector to vote in any particular manner or to refrain from voting, or who falsely makes, alters, forges or counterfeits any mail ballot before or after it has been cast, or who destroys, defaces, mutilates, or tampers with a ballot is subject, upon conviction, to imprisonment, or to a fine, or both. A ballot question listed as an "amendment" proposes a change to the Colorado constitution, and a ballot question listed as a "proposition" proposes a change to the Colorado Revised Statutes. A "yes/for" vote on any ballot question is a vote in favor of changing current law or existing circumstances, and a "no/against" vote on any ballot question is a vote against changing current law or existing circumstances.	Morgan County Ballot Issue 1A SHALL MORGAN COUNTY TAXES BE INCREASED UP TO \$3,000,000 IN 2020, AND BY WHATEVER AMOUNTS ARE RAISED ANNUALLY THEREAFTER BY IMPOSING A SALES TAX BEGINNING JANUARY 1, 2020 AT A RATE NOT TO EXCEED THREE QUARTERS OF ONE PERCENT (0.75%), THE PROCEEDS OF SUCH TAX WILL BE PLEDGED TO THE MORGAN COUNTY PARK AND RECREATION DISTRICT TO PROVIDE RECREATION SERVICES AND FACILITIES, AND SHALL MORGAN COUNTY AND THE RECREATION DISTRICT BE AUTHORIZED TO ENTER INTO AN AGREEMENT CREATING FINANCIAL OBLIGATIONS EXTENDING BEYOND THE CURRENT FISCAL YEAR TO PAY OVER THE PLEDGED REVENUES TO THE RECREATION DISTRICT, AND SHALL THE COUNTY SALES TAX REVENUES BE COLLECTED, RETAINED AND SPENT NOTWITHSTANDING ANY REVENUE LIMITS PROVIDED BY LAW; PROVIDED SUCH TAX SHALL ONLY BECOME EFFECTIVE IF THE ELIGIBLE ELECTORS APPROVE THE ORGANIZATION OF THE MORGAN COUNTY PARK AND RECREATION DISTRICT? <input type="radio"/> Yes/For <input type="radio"/> No/Against
