

ORDINANCE 94-14

TOWN OF OPHIR, COLORADO

AN ORDINANCE REQUIRING ORDINANCES TO BE PUBLISHED BY TITLE ONLY AND ESTABLISHING THE OFFICIAL PLACES OF POSTING FOR OFFICIAL NOTICES OF THE TOWN OF OPHIR

WHEREAS, the Town of Ophir desires to reduce the costs associated with the publication of Ordinances in full; and,

WHEREAS, the Town of Ophir desires to official recognize the habitual places of posting of Notices and Ordinances; and,

WHEREAS, the General Assembly of the Town of Ophir finds that the adoption of process and procedures for the posting of notices and publishing of ordinances will promote the efficient operation of Town government;

NOW, THEREFORE, BE IT ORDAINED BY THE GENERAL ASSEMBLY OF THE TOWN OF OPHIR, STATE OF COLORADO, the following:

SECTION 1: ORDINANCES PUBLISHED BY TITLE

All Ordinances adopted by the Town of Ophir shall be published in the official newspaper of record in San Miguel County by title only prior to final adoption, and after adoption, and shall include a reference that a copy of the entire Ordinance is available from the Town Clerk, including the name and phone number of the Town Clerk.

SECTION 2: OFFICIAL PLACES OF POSTING

The front entrance area of the Ophir Town Hall, located at 36 Porphyry, Ophir, Colorado, and the Ophir Post Office are designated as the official places of posting for all notices of official Town business and meetings.

SECTION 3. SEVERABILITY

If any provision of this ordinance or portion thereof is held by a court of competent jurisdiction to be invalid or unconstitutional, such invalidity or unconstitutionality shall not affect any other provision which can be given effect without the invalid portion.

SECTION 4. SAFETY CLAUSE

The adoption of this ordinance is necessary for the immediate protection of the public health, peace, safety and welfare.

SECTION 5. EFFECTIVE DATE


This ordinance shall be in full force and effect upon publication of notice of final adoption.

SECTION 6: CONFLICT WITH OTHER LAWS

This Ordinance supersedes any existing laws of the Town of Ophir or existing or future laws of the State of Colorado or of the United States of America, to the maximum extent permissible by homerule communities, that are in conflict with the express provisions of this Ordinance.
