

ORDINANCE NO. 1975-9

AN ORDINANCE SUMMARIZING EXPENDITURES AND REVENUES FOR EACH FUND, AND ADOPTING A BUDGET FOR THE TOWN OF LA JARA, COLORADO, FOR THE CALENDAR YEAR BEGINNING ON THE 1st DAY OF JANUARY 1976, AND ENDING ON THE LAST DAY OF DECEMBER 1976.

WHEREAS, the Board of Trustees of the Town of La Jara has appointed a budget committee to prepare and submit a proposed budget to said governing body at the proper time, and;

WHEREAS, upon due and proper notice, published or posted in accordance with the law, said proposed budget was open for inspection by the public at a designated place, a public hearing was held on the 9th day of December, 1975, and interested taxpayers were given the opportunity to file or register any objections to said proposed budget, and;

WHEREAS, whatever increase may have been made in the expenditures, like increases were added to the revenues so that the budget remains in balance, as required by law.

NOW, THEREFORE, BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE TOWN OF LA JARA, COLORADO:

Section 1. That the estimated expenditures for each fund are as follows.

General Fund	\$ <u>121,806</u>
Water & Sewer Fund	\$ <u>45,850</u>
Revenue Sharing Fund	\$ <u>12,350</u>
Policemen's Pension Fund	\$ <u>5,000</u>
Conservation Trust Fund	\$ <u>530</u>

Section 2. That estimated revenues for each fund are as follows:

Section 3. That the budget as submitted, amended, and hereinabove summarized by fund, be, and the same hereby is approved and adopted as the budget of the Town of La Jara for the year stated above.

Section 4. That the budget hereby approved and adopted shall be signed by the Mayor and the Town Clerk and made a part of the public records of the Town of La Jara.
