This matter is before the Colorado State Personnel Board ("Board") at its regularly scheduled meeting held on July 18, 2017. During this public session, the Board considered the Preliminary Recommendation of the Administrative Law Judge.

Based upon its review and consideration of the Preliminary Recommendation, the Board finds there is a sufficient basis to uphold the Preliminary Recommendation of the Administrative Law Judge to grant the petition for hearing on Complainant's claims of a violation of Board Rule 6-10 and age discrimination under the Colorado Anti-Discrimination Act and to deny the petition for hearing on Complainant's claim of hostile work environment.

IT IS HEREBY ORDERED that the Preliminary Recommendation of the Administrative Law Judge is adopted, and that the petition for hearing is **GRANTED** on Complainant's claims of a violation of Board Rule 6-10 and age discrimination under the Colorado Anti-Discrimination Act and the petition for hearing on Complainant's claim of hostile work environment. **DENIED**.
