This matter is before the Colorado State Personnel Board ("Board") at its regularly scheduled meeting held on October 18, 2016. During this public session, the Board considered the Preliminary Recommendation of the Administrative Law Judge.

Based upon the Board's review and consideration of the Preliminary Recommendation, the Board finds there is a sufficient basis to uphold the Preliminary Recommendation of the Administrative Law Judge to grant the petition for hearing to determine whether the Respondent violated Director's Administrative Procedure 8-89 regarding retaliation AND to modify the recommendation by granting a hearing on Complainant's Whistleblower claim.

IT IS HEREBY ORDERED that the Preliminary Recommendation of the Administrative Law Judge is adopted, with modification, and that the petition for hearing is **GRANTED** 1) to determine whether Respondent violated Director's Administrative Procedure 8-89 regarding retaliation and 2) to determine whether Respondent violated the Whistleblower Act.
