## *ACTION PLANS*

### **Background**

Hospitals participating in the Hospital Transformation Program (HTP) are required to engage organizations that serve and represent the broad interests of the community, including clinical providers, to identify community needs and resources to inform their applications to the HTP. The Community and Health Neighborhood Engagement (CHNE) process is intended to build on the strong spirit of collaboration within Colorado's health system and efforts and partnerships already underway. HTP participants are expected to engage, consult, and be informed by health neighborhoods and community organizations to identify community needs and inform the selection of transformation initiatives that address those needs during the planning process. Leveraging existing forums and collaborations will help to maximize community participation. Hospitals should align their engagement activities with advisory groups, existing programs and alliances, and statewide initiatives designed to strengthen the health care system.

Hospitals that are potential program participants submitted a CHNE Action Plan to the department that outlines how they will conduct the CHNE process. These plans are available to the public by request.
