

**Logan County Commissioners Work Session**  
**April 3, 2018**

Chairman Pelton called the meeting to order at 8:30 a.m.

**REVIEW OF BUSINESS MEETING AGENDA** - The Board reviewed the Business Meeting Agenda for the April 3, 2018 meeting.

CAPP fund for the salvage value. Commissioner McBride seconded and the motion carried 2-1. Commissioner Pelton voted against the motion and stated that the matter should be placed on a business meeting agenda due to a previous incident where a Commissioner objected to him signing a title outside of a business meeting.
