## 2019 Bull Riding

### Request for Proposal

The Logan County Commissioners and the Logan County Fair Board are accepting bids for the 2019 Bull Riding at the Logan County Fairgrounds to be held August 1 - 11, 2019.

The bid shall include:

1. Contractor will produce, manage and supply arena and rodeo stock for the Professional Bull Riding performance at the 2019 Logan County Fair.
2. Contractor will have use of the arena and the grandstands at Logan County Fairgrounds on Tuesday, August 6, 2019 for the production of the Professional Bull Riding event, which will commence at 7:00 p.m. on August 6, 2019.
3. Contractor is responsible, at its own cost, for supplying all bull riding stock, labor and personnel, portable arena, sound equipment, office space and equipment, announcers, judges, bullfighters, clown, pickup men, and related supplies and services for complete production of the Professional Bull Riding event with one specialty act (either Freestyle Bullfighting or Miniature Bull Riding), all as more particularly described in Contractor's written proposal.
4. Logan County shall be responsible for the following at its sole cost:
  - Providing and printing Event admission tickets
  - Providing ticket sellers and ticket takers, prior to and during the Event
  - Preparing the grandstand seating areas
  - Removing trash and debris from all stadium areas
  - Providing reasonable security prior to, during and after the Event
  - On-site ambulance services provided during the performance
  - Advertising through Logan County Fair & Rodeo's general fair advertising
5. Staff provided by the contractor or individuals associated with the Contractor in carrying out its responsibilities may not be employees of Logan County and will be considered and treated as independent contractors.
6. Contractor shall maintain in full force and effect, at its own expense, comprehensive general liability insurance coverage with a minimum coverage of \$1,000,000 each occurrence, \$1,000,000 general aggregate. Such insurance shall name "Logan County, Colorado, a body corporate and politic," as an additional insured and certificates of insurance for each participating organization shall be provided to Logan County no later than 3 days prior to commencement of the Event. In addition, Contractor shall provide Worker's Compensation insurance for its employees in the amounts required by Colorado law.

Submit your proposal to the Logan County Fair Board by 5 p.m. on March 29, 2019. All proposals should be submitted in a sealed envelope and marked with "Bull Riding". The Fair Board will be opening the proposals on April 11, at the Fair Board meeting. Notification will be April 19, after the Commissioners have approved the proposal. Supporting paperwork should include name of organization, address, supervising agent, telephone number and proposed amount, and if required proof of insurance.

The Board of Commissioners reserve the right to reject any or all bids and to accept the proposal deemed to be in the best interest of Logan County.
