All requests must be accompanied by a photocopy of the requestor's identification before processing. PLEASE RETURN YOUR REQUEST WITH A PHOTOCOPY OF YOUR DRIVER'S LICENSE, STATE ID OR PASSPORT.

This office will not have a record of the divorce, separation, or annulment if the county did not forward the information for the State Index. Verifications for the years 1940-1967 are not available from this office and must be obtained from the county where the dissolution was decreed. You may need to contact each of the counties if you do not know where the decree was granted. District courts are located in the county seat. A list of counties, county seats, and ZIP codes is provided for your convenience on the reverse side of this form.

Ways to order:

- Apply in person for same day service. Office hours are from 8:30 a.m. to 4:30 p.m., Monday-Friday.
- Order verifications online** at www.state.co.gov/cdphe/vitalrecords. Verification(s) mailed 2-3 days after receipt of all required documentation.
- Fax your application with credit card information:** within continental USA fax 1-800-423-1108; outside continental USA fax:1-303-691-9307. Verification(s) mailed in five business days upon receipt of all required documentation.
- Mail in application with check, money order, or credit card information.** Verification(s) mailed within three weeks upon receipt of all required documentation.
