## **Colorado XML Sales Tax Tests**

The Colorado sales XML schema has added a parent element for the state service fee cap that must be included with all sales xml returns for January 2020 filing period and forward. There are also some changes to the enumeration for deductions and exemptions to reflect changes to the Colorado sales tax form DR 0100 that take effect for the January 2020 filing period.

This package includes two tests for electronic filing via xml for Colorado sales tax. The scenarios include the location account number, gross sales amount and certain exemption amounts for each of the locations included. Test 1 will have a state service fee cap. Prepare the test 1 and test 2 xml return files that would be submitted to Colorado. Send the two test files as attachments by email to:
