- 3.6. Cardholders – State Agencies and Institutions of Higher Education shall only allow issue a Commercial Card to permanent State employees and shall not issue a State Commercial Card to contractors, temporary State employees, or non-State employees.

This is the notification to inform you that the State Controllers Office in the Colorado Department of Personnel & Administration will conduct a rulemaking hearing on the repeal and adoption of the State's Fiscal Rules (Rule 1 CCR 101-1). The general purpose of this hearing is to clarify rule language to comply with federal rules, regulations and guidance; align rules with the State's new Procurement Modernization Act; correct typographic errors and update rule language to comport with contemporary practices; and update rules as they relate to CORE.

This rulemaking hearing will consider the same repeal and adoption of State Fiscal Rules as a previous rulemaking - hearing noticed on March 28, 2018; Secretary of State tracking number 2018-00117. Docket 2018-00117 was terminated before its completion. If you commented to docket 2018-00117 you do not have to resubmit your comments. All comments and testimony provided to that docket will become part of the record in this docket and considered in this rulemaking.
