Hello Long-Term Services and Supports (LTSS) Stakeholders:

I want you to be aware of this opportunity for participation in stakeholder focus groups in a very important cross-departmental initiative. The Department of Health Care Policy & Financing and the Department of Human Services are working through the No Wrong Door Planning Grant to redesign and improve methods for people to learn about their options for Long-Term Services and Supports and to enroll in programs.

The first step in the work of the No Wrong Door Planning Grant are the stakeholder focus groups, held through a series of conference calls.
